SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 35), extending the target date in the above captioned investigation to February 11, 2009.

SUPPLEMENTARY INFORMATION: The Commission instituted Inv. No. 337-TA-613 on September 11, 2007, based on a complaint filed by InterDigital Communications Corp. of King of Prussia, Pennsylvania and InterDigital Technology Corp. of Wilmington, Delaware (collectively, "InterDigital") on August 7, 2007. 72 *Fed. Reg.* 51838 (September 11, 2007). The complaint, as amended, alleged violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain 3G mobile handsets and components by reason of infringement of certain claims of U.S. Patent Nos. 6,693,579 ("the '579 patent"); 7,117,004 ("the '004 patent"); 7,190,966 ("the '966 patent"); and 7,286,847 ("the '847 patent"). The notice of investigation named Nokia Corporation of Finland and Nokia Inc. of Irving, Texas (collectively, "Nokia") as respondents.

The Commission instituted Inv. No. 337-TA-601 on April 27, 2007, based on a complaint filed by InterDigital on March 23, 2007. 72 *Fed. Reg.* 21049 (April 27, 2007). The complaint, as amended, alleged violations of section 337 of the Tariff Act of 1930 (19 U.S.C. § 1337) in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain 3G wideband code division multiple access ("WCDMA") handsets and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 6,674,791, the '579 patent, the '004 patent, the '966 patent, and the '847 patent. The notice of investigation named Samsung Electronics Co., Ltd. of Seoul, Korea; Samsung Electronics America, Inc. of Ridgefield Park, New Jersey; and Samsung Telecommunications America LLC (collectively "Samsung") of Richardson, Texas as respondents. On October 24, 2007, the ALJ consolidated Inv. No. 337-TA-601 with Inv. No. 337-TA-613.

On April 14, 2008, the ALJ issued an order suspending the commencement of the evidentiary hearing in the consolidated investigation and any related submission deadlines pending resolution of a preliminary injunction entered against InterDigital by the U.S. District Court for the Southern District of New York, requiring InterDigital to suspend all actions in the current investigation with respect to Nokia.

On April 17, 2008, InterDigital moved to separate the previously consolidated investigations against Samsung (337-TA-601) and Nokia (337-TA-613). On May 16, 2008, the ALJ issued Order No. 33, granting InterDigital's motion to separate the investigations.

On July 10, 2008, the ALJ issued the subject ID under Commission rule 210.51(a) (19 C.F.R. § 210.51(a)), extending the target date in Inv. No. 337-TA-613 to February 11, 2009. No petitions for review of this ID were filed.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission's Rules of Practice and Procedure (19 C.F.R. § 210.42).
