Technical comments:³

The Commission notes that the subject product is not classified in HTS subheading 2933.39.61. The correct classification is 2913.00.40. In addition, the Commission notes that there is an existing temporary duty suspension under heading 9902.02.49 that expires on December 31, 2006. The Commission suggests that the bill be re-drafted to extend the existing duty suspension in heading 9902.02.49 by striking the date in the effective period column and inserting "12/31/2008" in lieu thereof.

³ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
