This serves as notice to the public of the action described below, taken by the Department official indicated (no additional confirming order will be issued in this matter).

Applicant: FAST AIR CARRIER S.A.

Date Filed: March 13, 1998

Relief requested: Exemption from 49 USC section 41301 to permit the applicant to conduct scheduled, all-cargo services, for a period of one year, as follows: 1) between Chile and the U.S. coterminal points Miami, Florida, and New York, New York; via the intermediate points Lima, Peru; Guayaquil, Ecuador; Manaus, Brazil; Rio de Janeiro, Brazil; Asuncion, Paraguay; Ciudad **del** Este, Paraguay; La Paz, Bolivia; Santa Cruz, Bolivia; Montevideo, Uruguay; Buenos Aires, Argentina; Cancun, Mexico; Caracas, Venezuela; **Cali**, Colombia; Montego Bay, Jamaica; **Punta Cana**, Dominican Republic; Guatemala City, Guatemala; Sao Paulo, Brazil; Quito, Ecuador; Manta, Ecuador; and Latacunga, Ecuador; and 2) between Chile and Los Angeles, California; via the intermediate points Lima, Peru, and Mexico City, Mexico.

If renewal, date and citation of last action: The authority to serve Cancun, Caracas, **Cali**, Montego Bay, **Punta Cana**, Guatemala City, Sao Paulo, Quito, Manta, and Latacunga is new authority. The other authority was most recently granted on November 12, 1997, in this Docket, and confirmed by Order **97-** 12-22.
