- 1. In this Order we consider the refund plan filed on June 7, 2002 by the above-referenced operator ("Operator")² in the above-referenced community pursuant to Order, DA 02-1051.³ ("Refund Order").⁴ Our review of Operator's refund plan⁵ reveals that the refund plan fulfills the requirements of the Refund Order.⁶
