RORC Associate Director Arrives

After an extensive search over the past two years, the Director and staff of the Rehabilitation Outcomes Research Center in Gainesville, Florida are pleased to announce that Rebecca J. Beyth, MD joined our Center as the Associate Director in January, 2005.

Dr. Beyth received her Bachelor of Arts *magna cum laude* from Case Western Reserve University in Cleveland, Ohio. Her Doctor of Medicine was completed at Jefferson Medical College in Philadelphia, Pennsylvania. Dr. Beyth also received a Master of Science in Biostatistics from the University of Michigan's School of Public Health. She completed her Medical Internship and Residency at Michigan State University Associated Hospitals in East Lansing.

Prior to coming to Gainesville, Dr. Beyth was an Assistant Professor of Medicine at Baylor College of Medicine in Houston, Texas, where she was also the Associate Director for Translational Research at the VA HSR&D Center for Quality of Care and Utilization Studies and Staff Physician, General Medicine, Houston Veterans Affairs Medical Center. She is the recipient of a National Institute on Aging (NIA) Career Development Award on improving the use of anticoagulant therapy in older patients, and a VA Advanced Career Development Award for improving decision making in stroke prevention.

In addition to her new role as the RORC Associate Director, Dr. Beyth is an Associate Professor of Medicine, Geriatrics Division in the College of Medicine and an Affiliate Associate Professor of Health Services Management and Policy in the College of Public Health and Health Professions at the University of Florida, as well as a Staff Physician at the Malcom Randall VA Medical Center.

Dr. Beyth's research interests include improving outcomes for patients with chronic diseases and patient-physician interactions in clinical decision-making. Her interest in anticoagulant therapy for stroke prevention is a natural fit with both the research program at the RORC and also the Stroke QUERI, where she will play an important role. RESEARCH HIGHLIGHT

Improving Anti-thrombotic Use for Stroke Prevention***

Atrial fibrillation is a common disorder and an important risk factor for stroke. Evidence from controlled clinical trials shows that adjusted-dose warfarin decreases the risk of stroke by two-thirds. Clinical practice guidelines recommend that most atrial fibrillation patients receive life-long anticoagulation; only about one-third of atrial fibrillation patients receive it. This study is a randomized controlled trial of an intervention (the RBC) to increase the appropriate use of antithrombotic therapy (warfarin and aspirin) for stroke prevention in patients with chronic atrial fibrillation.

The intervention is a tailored patient-specific riskbenefit consult (RBC) that incorporates the risks and benefits of anti-thrombotic therapy for stroke prevention using the American College of Chest Physicians guidelines and the Outpatient Bleeding Risk Index, a validated risk assessment for major bleeding. The intervention is aimed at primary care providers practicing in different clinical settings. Evidence-based specific recommendations about the use of anti-thrombotic therapy, as well as the quality of anti-thrombotic management will be formulated for each atrial fibrillation patient in the intervention physician's panel. The control and the intervention physicians will also receive performance feedback in the form of an Achievable Benchmark of

Care (ABC) that informs them of the percentage of their patient panel with atrial fibrillation that is receiving anti-thrombotic therapy in relation to the other physicians (intervention or control) in their group. The primary outcome is the change, pre-to post-intervention, in the proportion of eligible patients with chronic atrial fibrillation who are prescribed anti-thrombotics. This will be measured by the proportion of the eligible patients in each physician's panel for whom anti-thrombotics are currently prescribed at baseline, 6-months, and 12months. Secondary safety outcomes are the proportion of individuals in the physician's panel with stroke, the proportion of anticoagulated patients with major bleeds, and the proportion of total treatment time during which the International Normalized Ratio is below, above and within therapeutic range. This study will test a novel and generalizable approach to increasing the appropriate use of anti-thrombotic therapy in patients with atrial fibrillation in a community setting and the findings will provide valuable insight into stroke prevention.
