<u>Description of Activity:</u>

SCCAO will as a continuing activity provide over sight to public and non-public requests to use portions of the Friant-Kern Canal, Madera Canal, Millerton Reservoir, and other lands designated as part of this division's right of way for activities associated with its intend use. To ensure the protection of the facility, reviews of the current and proposed uses of lands associated with those facilities will be ongoing. Resolution of identified trespass and unauthorized activities will be conducted. Reclamation is authorized and associated structures, lands clerk and GIS specialist. Funding requests for this FY exceed prior year activities due to contract obligations for a final year of land surveys of the Friant-Kern Canal and Madera Canal right-of-ways. The land surveys will provide this office and the OM&R partners with reliable information to surveys will also be included within an automated lands information data base that complies with Reclamation's automation initiative. Base GIS and tabular data information will be collected through contract to provide a current detail of ownership and authorized uses of the facilities. In addition, land use compliance activities will be required to implement the Resource Management Plan for Millerton Lake and the accompanying renegotiation of the grazing and recreation contracts.

Impact(s) if Unfunded:

The basic of the projects ability to service the customer of the Friant-Kern Canal and the Madera Canal rests on the adequate over sight and protection of the facility. This protection will be reduced if this program is not fully funded, and the results will be a deterioration of the facilities. Included in the funding is the review of potential tort claims arising from flooding associated with the unit. While actual flooding is not a predictable condition, Reclamation has been required to expend energy and funds on an annual basis for this activity. Not funding this portion will place Reclamation into a reactive program at the expense of other needed activities. The direction towards automating the lands information if not funded will limit this office's ability to respond to requests for use, assessment of impacts by continued developments of lands adjacent to facilities. The process of approval of new developments state, county, and local entities is becoming increasingly rapid requiring Reclamation to avail itself of tools to adequately assess those developments.

A number of consultations with the Fish and Wildlife Service under Section 7 of the Endangered Species Act resulted in biological opinions covering interim and long-term water service contractors, continued operation and maintenance of Reclamation facilities, and other site-specific Federal actions. Reclamation is committed to implementing projects and Programs to ensure that the continued existence of federally threatened and endangered species (listed species) would not be jeopardized.

Impact(s) if Unfunded:

Reclamation is presently operating under a number of biological opinions with non-discretionary terms and conditions. If this activity is unfunded, Reclamation may need to reinitiate consultation with the U.S. Fish & Wildlife Service.

Impact(s) if Unfunded:

If not funded or partially funded water rights holders down stream of Friant may not receive their water to the extent called for within their contracts. Water may be released over the required contact flows, which will cut into the allocation of long term contractors within the Friant service area. This in turn would be a loss of revenue.

This critical study will determine the location and quantity of expected future land subsidence in the Federal areas of the San Joaquin Valley, and will assess the water delivery disruptions, capacity reductions, and facility damage that the land subsidence would cause. The overall study should include water districts served by CVP deliveries in the Friant, San Luis, and Delta Divisions. The funding requested in this Activity Plan is for the Friant Division portion of the study.

Impact(s) if Unfunded:

The land subsidence analysis for the CVPIA Programmatic EIS is not sufficiently site-specific to allow Reclamation to start planning how to avoid or mitigate the facility and delivery impacts that will occur if the PEIS projections are accurate. Presently, tools are not available for accomplishing a high-resolution land subsidence evaluation of the area. Without a proposed study, Reclamation may not be prepared for these future impacts.

Activity Authorization:

SCCAO staff administer the NEPA process and provide professional assistance in agriculture, biology, chemistry, geology, hydrology, and other natural sciences to facilitate CVP activities.

Impact(s) if Unfunded:

Without the proposed funding, activities by Reclamation, the contractors, and the Friant Water Users Authority will not be adequately reviewed to ensure compliance with environmental policy and law, thus compromising public safety, potentially harming listed species and habitat, and improperly managing water and related resources in the public interest. Reclamation is required to comply with NEPA. Some actions such as water transfers would be delayed.

Hydrilla Verticillata Royle (hydrilla) is a noxious aquatic weed. Once established, hydrilla develops dense mats that produce a canopy over the water surface. This canopy prevents the transmission of light though the water column, resulting in loss of native and essential vegetation, destruction of fish and wildlife habitats, degradation of water quality, alteration in fish predator-prey relationships, and a depression of dissolved oxygen concentration which can lead to massive fish kills. Dense infestations of hydrilla prevents the use of water systems for industrial, agricultural, domestic, and recreational purposes. Hydrilla clogs rivers, streams, canals, and ditches, reducing their capacity and preventing the timely delivery of water to customers.

This program is to control the growth and spread of hydrilla.

Impact(s) if Unfunded:

Without a program to detect and eradicate this pernicious aquatic weed, environmental damage would occur, and Reclamation's ability to deliver water and meet contracts would be impeded. The result could be substantial economic loss.

Activity Authorization:

Section 1453 of Public Law 101-624, Amendment to the Noxious Weed Act (104 Stat. 3611) and Public Law 104-46.

Aquatic and ditchbank weeds located in, on, and adjacent to water storage, conveyance, and distribution systems are a threat to native aquatic species diversity, irrigated agriculture, and to essential water uses, including municipal and industrial water, water-dependent recreation, and water conveyance and storage systems. Aquatic weeds also prevent timely delivery of water, increase the cost of delivering water, lower the quality and quantity of available water, and adversely affect fish. Direct annual losses caused by aquatic and ditchbank weeds exceeds \$500 million. An estimated 2 million acre-feet of water is lost annually due to aquatic weeds, which equates to a \$110 million loss in productive value.

This cooperative agreement provides basic and applied research on the growth and reproduction of such weeds as Hydrilla verticillata Royle (hydrilla), Egeria densa (egeria), and waterhyacinth; and of biological controls and herbicide efficacy.

Impact(s) if Unfunded:

Without a program to effectively control or eradicate these pernicious aquatic weeds, environmental damage would occur, and Reclamation's ability to deliver water and meet contracts would be impeded. Waterways would be clogged, water quality and quantity would be reduced, the cost of delivering water would increase, the quality of aquatic habitat would decrease, and water-dependent recreation would be greatly reduced. The result could be substantial economic loss.

Soil and moisture conservation will be furthered through development and implementation of watershed management strategies. The primary goal of this activity is to protect Public Health and Safety through reduction of wildfire risk, management of wastes and hazardous materials, improved water quality, and reduced soil erosion.

Impact(s) if Unfunded:

Public Health and Safety will be jeopardized. Reclamation will not be able to provide low cost fire protection, and manage erosion and water quality to meet NPDES requirements.
