Mississippi Hurricane Gustav – FEMA-1794-DR

Declared September 22, 2008

On September 2, 2008, and amended on September 3, 8, and 10, 2008, Governor Haley Barbour requested a major disaster declaration due to severe weather, flash flooding and storm surge caused by Hurricane Gustav during the period of August 28 to September 8, 2008. The Governor requested a declaration for Individual Assistance for three counties, Public Assistance for 20 counties, emergency protective measures, including direct Federal assistance for 62 counties, and Hazard Mitigation for all counties. The Governor further requested 100 percent Federal funding for emergency protective measures (Category B), including direct Federal assistance, for the first 72 hours. During the period of September 4-9, 2008, joint Federal, State, and local Preliminary Damage Assessments (PDAs) were conducted in the requested counties and are summarized below. PDAs estimate damages immediately after an event and are considered, along with several other factors, in determining whether a disaster is of such severity and magnitude that effective response is beyond the capabilities of the State and the affected local governments, and that Federal assistance is necessary.

On September 22, 2008, President Bush declared that a major disaster exists in the State of Mississippi. This declaration made Public Assistance requested by the Governor available to State and eligible local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged by Hurricane Gustav in Adams, Amite, Claiborne, Copiah, Forrest, Franklin, George, Hancock, Harrison, Jackson, Jefferson, Jefferson Davis, Lawrence, Lincoln, Marion, Pearl River, Pike, Stone, Walthall, and Wilkinson Counties. Direct Federal assistance also was authorized. Finally, this declaration made Hazard Mitigation Grant Program assistance requested by the Governor available for hazard mitigation measures statewide.²

Information collected is used by the State as a basis for the Governor's request for a major disaster or emergency declaration, and by the President in determining a response to the Governor's request (44 CFR § 206.33).

² When a Governor's request for major disaster assistance under the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended (Stafford Act) is under review, a number of primary factors are considered to determine whether assistance is warranted. These factors are outlined in FEMA's regulations (44 CFR § 206.48). The President has ultimate discretion and decision making authority to declare major disasters and emergencies under the Stafford Act (42 U.S.C. § 5170 and § 5191).
