# I. Executive Summary:

World Vision, Inc. implements the Children at High Risk Prevention Project (CHRPP) in the rural locations of Rattanak Mondol district of Battambang province, Prasath Ballang district of Kompong Thom province, Kandal Steung district of Kandal province, and Tralach district of Kompong Chhnang province.

This project focuses on improving child protection and income generation in rural communities as a way of preventing family dissolution and unhealthy migration to urban areas. It has a very strong emphasis on child participation. The objective is to target disadvantaged and at risk children, especially girl children, to prevent violence against children, child labor, and other forms of child abuse. The activities include basic education and training using non-formal, formal and vocational education, awareness raising of child rights and child protection, and HIV/AIDS prevention. Income generation will be encouraged through the provision of small business development incentives, cow banks and vocational training.

The project will strengthen civil society through the establishment of village Children/Youth Clubs (CYC), capacity building of existing community organizations such as Village Development Committees (VDC) and Commune Council (CC) members (elected in February 2002), and through existing district government staff in MOSALVY. The project will collaborate with a number of Cambodian and International NGOs in the implementation of these activities and to advocate for improved Government policy and practice in responding to the needs and rights of children.

In this quarter (1 April - 30 June 2005), there were about 2.754 people including more than 1.506 girls and women participating in the project activities. Few of planned project activities were not accomplished, and others were completely achieved as plan. Following is a summary of project achievements during the quarter.

## II. Achievements in the Reporting Period

The report of the project mid-term evaluation was completed, and the plan of action to response to the recommendation in order to improve the quality of the project was completed and will be accomplished in the next quarter in cooperation with he ADP staff.

## Capacity of community and children was built through:

- The project in cooperation with VDCs, villager chiefs, ADP staff and school master built one children club shelter in Baray primary school of Prasath Ballang district, Kampong Thom Province
- 80 children (g=43, b=37) joined children club meeting in Krouse, Krabao, Dong, Samraung and Trach village of Dong commune, Prasath Ballang district, Kampong Thom Province, and 168 children (g=84, b=84) participated the meeting in Kampong Tralach district.
- The project organized International Children Day for
  - ➤ 500 children (f=260, b=240) and 80 people (f= 50, m=30) in Chanserey and Chunlouse communes of Prasath Ballang district. The event included club competition, drawing picture, writing poem, singing songs and other fun activities.
  - ➤ 1,200 children (g=732, b=468) from 23 children clubs in Kampong Tralach district, 6 project staff, 10 teachers (f=3, m=7) and 25 VDCs (f=20, m=5), 2 MOSVY staff (f=1, m=1) and one deputy district governor. The competition among clubs was made: questions and answers related to CRC, trafficking, health, drug use and other CEDC issues and incentives were also provided too.

- 287 children (g=174, b=113) participated in the mobile library activities on the issue of the disadvantages of drug using which is run by peer educator groups in ten village from Thnal, Kampeut, Talek, Mareak Khnor village in Salavisay and Tamom, Thmey, Trach, Krous village in Duong and Samaky communes, Prasath Ballang district, Kampong Thom province.
- The peer educator groups with support from VDC run project club activities with focus on CRC, trafficking and drug use for:
  - ➤ 175 children (g=89, b=86) in Kampong Tralach district, Kampong Chhnang province.
  - ➤ 320 children (g=145, b=175) and 17 adults (f=10, m=7) in Kandal Steung district, Kandal province.
  - ➤ 287 children (g=174, b=113) in Prasath Ballang district, Kampong Thom province.

• The project sent 2 children club leaders (g=1, b=1) to attend the training on Karaoke Safe Video organized by Tear-Fund in Phnom Penh.

#### Government Capacity was built through:

No achievement in this quarter because most of the activities were achieved in the previous quarter in Prasath Ballang districts, Kampong Thom and some activities were delayed in Kampong Tralach district, Kampong Thom province since the staff was resigned. The new staff will be recruited and put in place in the next quarter.

### Livelihood improvement program has been initiated through:

- The project provided 9 cows to 27 poorest families in 2 communes: Dong and Samaky, of Prasath Ballang district, Kampong Thom province.
- The project purchase 22 bicycles were purchased and provided to poorest families in 7 villages: Krouse, Dang Taek, Tamom, Thmey, Trach, Saraung and Chanserey in Prasath Ballang district Kampong Thom province
- The project supported 20 girls from 6 villages in 3 communes of Kampong Tralach district, Kampong Chhnang province to attend sewing skill training starting from 13 May 2005.

# 2. Expectations & Achievements ('not met', 'met', or 'exceeded')

Generally, the project met expectations especially in building capacity of the children, the establishment of children clubs, and workshop training with community, and schoolchildren. Most activities proceeded according to plan.

However, the livelihood program involving the distribution of cows took longer than anticipated to establish. The purchase of cows was hindered by the increase in cattle prices and the time-consuming nature of obtaining appropriate quotes and the staff communication behavior change was not achieved because of the government health staff was not available. However, this will carried out for the next quarter.

# 4. Key Activities and Progress Achieved (this reporting period)

With good collaboration with VDCs, local staff and villagers:

- 1 new children club was established in Prasath Ballang district.
- 248 children (g=127, b=121) participated in children club monthly meeting in Prasath Ballang and Kampong Tralach district
- 1700 children (g=992, b=708), 80 community people, 10 teachers (f=3, m=7), 25 VDCs, 2 MOSVY staff and 1 deputy district governor participated in the International Children Day celebration in Kampong Tralach and Prasath Ballang district.
- 782 children (g=408, b=374) and 8 VDCs and 17 community people join supporting the mobile library activities in Kampong Tralach, Kandal Steung and Prasath Ballang district.
- The project provided 9 cows to 27 poorest families in Prasath Ballang district
- The project provided 22 bicycles to the poorest families in Prasath Ballang district
- The project supported 20 girls to attend sewing skill training in Kampong Tralach district

# 5. Human Resources Development and Staff Changes

Since the project has started for 1 year and 6 months, all needed staff is in place. However, there was also change to the project staff. Details are as below:

- The project send one female staff from Prasath Ballnag district to attend the Celebration of Children workshop conducted by Tear-Fund. The workshop focused on improving child-care knowledge.
- Project Field Coordinator attended Project Implementation course in Phnom Penh.

# 11. Lessons Learned, including Constraints

With cooperation from World Vision Area Development Program (ADP) staff, VDCs, local leaders and commitment from children, the project preceded the activities smoothly. Project staff will need to continue to cultivate this good will.

Few of activities were not achieved such as cow bank, vocational skill training, and health training due to the difficulty in finding healthy cows, hesitation of poorest families to send children to attend the training, and time constraint of health staff respectively.

#### 12. Other Comments

• For FY05, we will move activities in OUTPUT 2.1 (Increase awareness by MOSALVY government department staff on child protection CRC/CEDC issues) to do with schoolteacher

- since they work closely with children and they can communicate about CRC, trafficking and CEDC issues with children effectively.
- For the FY05, activities in OUTPUT 2.2 (MOSALVY staff training as peer educator to monitor child protection) will not be carried out because UNICEF already implemented this activity several times with MOSVY.
- The project plan to do the end of project valuation in October 2005. We are in the process of developing TOR.
- The project requested for 2 months no-cost extension. The main reasons for a request are as follows:
  - First, the project has recently carried out a mid-term review and in order to fully implement the recommendations, additional time is needed.
  - > Second, in order to have a good project evaluation and to allow sufficient time between the mid-term and final evaluation, an extension is required.
  - Third, a two-month extension will ensure a quality closeout and transition process that will significantly impact the sustainability of the project as it seeks to continue to target these high-risk children on a smaller scale.

# Special Story: Vulnerable family who received pig loan from the project

My name is Mom En and I was born in 1960. My wife is Chhorn Khor. I have two sons and two daughters. My oldest son is 17 years old, the second daughter is 16 years old, the third son is 13 years old, and the last daughter is 10 years old. I am a disabled man: I have my leg cut due to mine explosion.



I am a farmer and I climb up palm trees to get palm juice to sell for supporting my family. Besides this I spent time to repair bicycle to supplement our family income.

I received pig grant from Children at High Risk Prevention Project of World Vision Cambodia based in Prasath Balang district of Kampong Thom province. After six months of pig raising, our family sold it to the middle broker and we used the money earned to purchase new pig and rice for supporting my

family living as well as repairing our old thatched-house. Beside that I was also able to use the money earned to buy some materials for bicycle repair so that I can earn some extra money.

Now, I can earn some money from repairing the bicycles. I hope this repairing skill will generate more income. Moreover through ongoing pig raising, I hopes our family will, at least, improve step by step.
