FORFEITURE ORDER

Adopted: July 29, 2002 Released: August 1, 2002

By the Chief, Enforcement Bureau:

- 1. In this *Forfeiture Order* ("*Order*"), we issue a monetary forfeiture in the amount of four thousand dollars (\$4,000) to WRHC Broadcasting Corp. ("WRHC"), licensee of Station WRHC(AM), Miami, Florida, for willful violation of Section 11.35(a) of the Commission's Rules ("the Rules"). The noted violation involves WRHC's failure to have Emergency Alert System equipment in operation on March 28, 2002.
- 2. On May 7, 2002, the District Director of the Commission's Tampa, Florida Field Office issued a *Notice of Apparent Liability for Forfeiture* ("NAL")² in the amount of \$4,000 to WRHC. WRHC has not filed a response to the NAL. Based on the information before us, we affirm the forfeiture.
- 3. **ACCORDINGLY, IT IS ORDERED THAT**, pursuant to Section 503(b) of the Communications Act of 1934, as amended, ("the Act"),³ and Sections 0.111, 0.311 and 1.80(f)(4) of the Rules,⁴ WRHC Broadcasting Corp. **IS LIABLE FOR A MONETARY FORFEITURE** in the amount of \$4,000 for willfully violating Section 11.35(a) of the Rules.
- 4. Payment of the forfeiture shall be made in the manner provided for in Section 1.80 of the Rules⁵ within 30 days of the release of this *Order*. If the forfeiture is not paid within the period specified, the case may be referred to the Department of Justice for collection pursuant to Section 504(a) of the Act.⁶ Payment shall be made by mailing a check or similar instrument, payable to the order of the "Federal Communications Commission," to the Federal Communications Commission, P.O. Box 73482, Chicago, Illinois 60673-7482. The payment should note NAL/Acct. No. 200232700007, and FRN 0005-
