1. In the General Contents make the following pen and ink change under Part Two-Conditions Affecting Entitlement, Chapter 1. Employment:

"Section A-Reporting Requirement.....20101-20102"

2. Change the title of Part Two-Conditions Affecting Entitlement, Chapter 1-Employment, Section A to a singular reporting requirement by deleting the "s" in the title line and rewriting paragraph 20101 to read:

"20101. General

Certain retired members, as specified below, are required to adhere to laws and regulations pertaining to conflict of interest and civilian employment by the Federal Government."

3. Delete current (was previously renumbered in Interim Change R12-95) paragraph 20102. DD Form 1787, Report of DoD and Defense-Related Employment in its entirety.

4. Renumber current (was previously renumbered in Interim Change R12-95) paragraph 20103. Notification of Personnel Action to read:

"20102. Notification of Personnel Action."

5. Change paragraph 20131d(1) to read:

"20131d(1). a retired Regular officer is convicted of violating 18 U.S.C. 281(a) during any period prior to 13 October 1994, or"

6. Change paragraph 20132a to read:

"20132a. "Selling", as an activity under the conflict of interest law, is prohibited during any time prior to 13 October 1994, under 18 U.S.C. 281(a). A retired Regular officer may..."

7. In the Glossary of Terms, delete the term "Renounced Pay."

8. In the Bibliography, delete the reference to **current paragraphs 20102 and 20102e.**

9. In the Bibliography, renumber the current (was previously changed in Interim Change R12-95) reference to paragraph 20103d to read **20102d.**

10. Add the following to the Bibliography:
