Title: Market-Based Rates for Wholesales Sales of Electric Energy, Capacity and Ancillary Services by Public Utilities

Abstract: The Commission amends its regulations to clarify: (1) The effective date for compliance with Order No. 697; (2) which entities are required to file updated market power analyses for the Commission's regional review; (3) the data required for the horizontal market power analyses; and (4) what constitute "seller-specific terms and conditions" that sellers may list in their market-based rate tariffs. The Commission amended its regulations governing market-based rates for public utilities to codify and revise its current standards for obtaining market-based rate authority for sales of electric energy, capacity and ancillary services. Abstract: The Commission proposes to make permanent interim regulations that respond to the Court of Appeals by making the standards of conduct inapplicable to the relationship between natural gas pipeline transmission providers and their energy affiliates. The Commission also proposes to revise the definition of marketing, sales or brokering; make permanent the changes adopted in the interim rule for risk management employees and discretionary waivers. The Commission will remove the regulations that permit transmission providers to share with their energy affiliates information necessary to maintain the operations of their transmission systems; add and revise various regulations to facilitate integrated resource planning and competitive solicitations. The regulations will be revised to: (1) Require each transmission provider to post the name of its chief compliance officer and delete outdated references; (2) require that transmission provider employees certify that they completed standards of conduct training; and (3) revise the definition of affiliate for exempt wholesale generators. (Docket No. RM07-1-000).

Abstract: The Commission amends its regulations to expand abandonment authority to permit abandonment of facilities constructed prior to the blanket certificate program if they meet certain conditions regarding the cost of the facilities. The Commission amended its part 157 blanket certification regulations to expand the scope and scale of activities that may be undertaken pursuant to blanket certificate authority. The Commission expanded the types of natural gas projects permitted under blanket authority and increased the cost limits that apply to blanket projects. In addition, the Commission clarified that a natural gas company is not necessarily engaged in an unduly discriminatory practice if it charges different customers different rates for the same service based on the date that customers commit to service.
