### **AN ACT**

**AMENDING SECTIONS 28-672, 28-675 AND 28-676, ARIZONA REVISED STATUTES;  
RELATING TO MOTOR VEHICLE ACCIDENTS.**

1 Be it enacted by the Legislature of the State of Arizona:  
2       Section 1. Section 28-672, Arizona Revised Statutes, is amended to  
3 read:

4           28-672. Causing serious physical injury or death by a moving  
5           violation; classification; penalties; definition

6       A person is guilty of causing serious physical injury or death by a  
7 moving violation if the person violates any one of the following and the  
8 violation results in an accident causing serious physical injury ~~as defined~~  
9 ~~in section 13-105~~ or death to another person:

- 10      1. Section 28-645, subsection A, paragraph 3, subdivision (a).
- 11      2. SECTION 28-729.
- 12      3. SECTION 28-771.
- 13      2. 4. Section 28-772.
- 14      3. 5. Section 28-792.
- 15      4. 6. Section 28-794.
- 16      5. 7. Section 28-797, subsection E or G.
- 17      6. 8. Section 28-855, subsection B.
- 18      7. 9. Section 28-857, subsection A.

19       B. A person who violates this section shall attend and successfully  
20 complete traffic survival school training and educational sessions that are  
21 designed to improve the safety and habits of drivers and that are approved by  
22 the department. In addition, the court may order the person to perform  
23 community restitution.

24       C. The court shall report a conviction for a violation of this section  
25 to the department and may direct the department to suspend the person's  
26 driving privilege for not more than ninety days if the violation results in  
27 serious physical injury ~~as defined in section 13-105~~ and not more than one  
28 hundred eighty days if the violation results in death.

29           D. IF WITHIN A PERIOD OF THIRTY-SIX MONTHS A PERSON IS CONVICTED OF A  
30 SECOND OR SUBSEQUENT VIOLATION OF THIS SECTION, THE COURT SHALL DIRECT THE  
31 DEPARTMENT TO SUSPEND THE PERSON'S DRIVING PRIVILEGE FOR NINETY DAYS IF THE  
32 VIOLATION RESULTS IN SERIOUS PHYSICAL INJURY AND ONE HUNDRED EIGHTY DAYS IF  
33 THE VIOLATION RESULTS IN DEATH.

34           E. If a person's driving privilege is suspended pursuant to any  
35 other statute because of an incident involving a violation of this section,  
36 the suspension period prescribed in subsection C of this section shall run  
37 concurrently with the other suspension period.

38           F. If a person fails to successfully complete traffic survival  
39 school training and educational sessions or perform community restitution  
40 pursuant to this section, the court shall notify the department and the  
41 department shall promptly suspend the driver license or permit of the driver  
42 or the privilege of a nonresident to drive a motor vehicle in this state  
43 until the order is satisfied.

1        ~~F.~~ G. If the person who suffers serious physical injury as a result  
2 of a violation of this section appears before the court in which the action  
3 is pending at any time before trial and acknowledges receipt of satisfaction  
4 for the injury, on payment of the costs incurred, the court shall order that  
5 the prosecution be dismissed and the defendant be discharged. The reasons  
6 for the order shall be set forth and entered of record, and the order shall  
7 be a bar to another prosecution for the same offense.

8        ~~G.~~ H. Restitution awarded pursuant to section 13-603 as a result of a  
9 violation of this section shall not exceed ten thousand dollars.

10        ~~H.~~ I. A person who violates this section is guilty of a class 3  
11 misdemeanor, except that if the violation results in the death of another  
12 person the maximum fine for the person shall be one thousand dollars.

13        J. FOR THE PURPOSES OF THIS SECTION, "SERIOUS PHYSICAL INJURY" HAS THE  
14 SAME MEANING PRESCRIBED IN SECTION 13-105.

17        A. A person is guilty of causing death by use of a vehicle if all of  
18 the following apply:

19        1. The person is not allowed to operate a motor vehicle pursuant to  
20 subsection B of this section.

21        2. While operating a motor vehicle, the person causes the death of  
22 another person.

23        3. The person commits a violation of any of the following:

24        (a) Section 28-645, subsection A, paragraph 3, subdivision (a).

25        (b) SECTION 28-729.

26        (c) SECTION 28-771.

19 injury, as defined in section 13-105, to another person.
