JURISDICTION AND VENUE

11 2. This Court has subject matter jurisdiction over this
12 matter pursuant to 15 U.S.C. §§ 45(a), 52, and 53(b), and 28
13 U.S.C. §§ 1331, 1337(a) and 1345.

3. Venue in the United States District Court for the
Central District of California is proper under 15 U.S.C. § 53(b)
and 28 U.S.C. §§ 1391(b) and (c).

PARTIES

Plaintiff, the Federal Trade Commission, is an 18 4. 19 independent agency of the United States Government created by 20 statute. See 15 U.S.C. §§ 41-58. The FTC enforces Section 5(a) 21 of the FTC Act, 15 U.S.C. § 45(a), which prohibits unfair or 22 deceptive acts or practices in or affecting commerce. At 17 all times material to this Complaint, acting alone or in concert 18 with others, Funes has advertised, marketed, sold and distributed 19 Celu-Fat Reductor. Funes transacts or has transacted business in the Central District of California. 20

7. Defendant Leonardo Spelzini ("Spelzini") is a general
partner of Rosario. At all times material to this Complaint,
acting individually or in concert with others, he has formulated,
directed, controlled, or participated in the acts and practices
of Rosario, including the various acts or practices set forth in

Defendant Hector De Nigris ("De Nigris") is president 9. 12 of Funes. At all times material to this Complaint, acting 13 individually or in concert with others, he has formulated, 14 directed, controlled, or participated in the acts and practices 15 of Funes, including the acts or practices set forth in this 16 Complaint. His principal office is 8880 Benson Avenue, Suite 17 110, Montclair, California 91763. De Nigris transacts or has 18 transacted business in the Central District of California. 19

21 10. The acts and practices of the defendants, as alleged 22 herein, have been in or affecting commerce, as "commerce" is 23 defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

DEFENDANTS' COURSE OF CONDUCT

11. Since 2003, defendants have advertised, promoted,

1 offered for sale, sold, and distributed a purported weight loss product called Celu-Fat Reductor to consumers throughout the 2 3 United States. According to defendants, Celu-Fat Reductor is a weight loss program that consists of a massage gel, a herbal 4 5 wrapping lotion, and a thermal belt or girdle. The massage gel is a cream that consumers rub into their skin once a day. The 6 massage gel contains, among other ingredients, carrot extract, 7 hydrolyzed glycosaminoglycans, and guarana extract. The herbal 8 wrapping lotion is a liquid substance that consumers apply to 9 terry cloth bandages and wrap around their mid-section. 10 The 11 herbal wrapping lotion contains, among other ingredients, witch hazel extracts, aloe vera gel, ginger extract, and cellulose gum. 12 The thermal belt is a heated belt that consumers wrap around 13 parts of their body. The plaster girdle is a device that 14 encircles the body's mid-section and is tightened in the back. 15 Defendants have advertised Celu-Fat Reductor throughout 16 12. the United States through 60-second, Spanish-language television 17

18 commercials. Consumers purchased Celu-Fat Reductor by calling a
19 toll-free telephone number that appeared in the television
20 commercial. Defendants sold Celu-Fat Reductor for \$129.50.

21 13. To induce consumers to purchase Celu-Fat Reductor,
22 defendants have disseminated or have caused to be disseminated
23 advertisements for Celu-Fat Reductor, including but not
24 necessarily limited to the attached Exhibits A through D. These
25 advertisements contain the following statements and depictions,

COUNT TWO: Unsubstantiated Claim

Defendants did not possess and rely upon a reasonable 17. basis that substantiated the representations set forth in Paragraph 15 above at the time the representations were made. Therefore, the making of the representations set forth in 10 11 Paragraph 15 above constitutes a deceptive act or practice, and the making of false advertisements, in or affecting commerce, in 12 13 violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 14 45(a) and 52.

CONSUMER INJURY

Consumers throughout the United States have suffered 16 18. substantial monetary loss as a result of defendants' unlawful 17 acts or practices. In addition, defendants have been unjustly 18 enriched as a result of their unlawful practices. Absent 1.920 injunctive relief by this Court, defendants are likely to continue to injure consumers, reap unjust enrichment, and harm 21 the public interest. 22

THIS COURT'S POWER TO GRANT RELIEF

Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), 24 19. 25 empowers this Court to grant injunctive and such other relief as

the Court may deem appropriate to halt and redress violations of the FTC Act. The Court, in the exercise of its equitable jurisdiction, may award other ancillary relief, including but not limited to, rescission of contracts, restitution, and the disgorgement of ill-gotten gains, to prevent and remedy injury caused by defendants' law violations.

PRAYER FOR RELIEF

8 WHEREFORE, plaintiff requests that this Court, pursuant to 9 Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), and the Court's 10 equitable powers:

(1) Permanently enjoin defendants from violating Sections 5 and 12 of the FTC Act in connection with the advertising or sale of food, drugs, dietary supplements, devices, cosmetics or other products, services or programs;

(2) Award such equitable relief as the Court finds necessary to redress injury to consumers resulting from the defendants' violations of Sections 5(a) and 12 of the FTC Act, including but not limited to, rescission of contracts, restitution, and the disgorgement of ill-gotten gains by the defendants; and

(3) Award plaintiff such other equitable relief as theCourt may determine to be just and proper.







Once you have finished wrapping the terry cloths and (treated area must be kept as warm as possible) Remain covered for 15-20 minutes (Fig. 6). After this time has plastic wrap, lay down and cover yourself with a blanket. elapsed, remove the terry cloths and wash thoroughly for later use.




Fig. 3 - Apply using upward strokes on legs and thighs.





Fig. 5 - Wrap the legs and thighs with the smaller terry cloths.




Fig. 4 - Wrap the stornach an with the targer piece of terry clott
