
**Product information, including uses/applications and source(s) of imports:**

Isoxadifen-Ethyl is a synthetic organic chemical used as a safener in certain herbicides to control annual and perennial grasses, as well as broadleaf weeds, in corn. The safener protects the crop from adverse effects caused by the pesticide. Isoxadifen-Ethyl is imported from Germany and then formulated into herbicides for sale in the domestic market. There are several domestic companies that market competing products, but none uses this chemical in their formulations.

## A BILL

To suspend temporarily the duty on Ethyl 4,5-dihydro-5,5-diphenyl-1,2-oxazole-3-carboxylate (Isoxadifen-ethyl).

3 **SECTION 1. ETHYL 4,5-DIHYDRO-5,5-DIPHENYL-1,2-OXAZOLE-**

4 **3-CARBOXYLATE (ISOXADIFEN-ETHYL).**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of  
6 the Harmonized Tariff Schedule of the United States is  
7 amended by inserting in numerical sequence the following  
8 new heading:
