AN ACT

AMENDING SECTION 28-2354, ARIZONA REVISED STATUTES, AS RENUMBERED BY LAWS 1996, CHAPTER 76, SECTION 7; AMENDING SECTION 28-2354, ARIZONA REVISED STATUTES, AS AMENDED BY LAWS 2006, CHAPTER 377, SECTION 1; RELATING TO LICENSE PLATES.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 28-2354, Arizona Revised Statutes, as renumbered by
3 Laws 1996, chapter 76, section 7, is amended to read:
4 28-2354. License plates; attachment
5 A. A person shall display the license plate or plates as follows:
6 1. EXCEPT AS PROVIDED IN PARAGRAPH 3 OF THIS SUBSECTION, for a motor
7 vehicle, motorcycle, trailer or semitrailer, on the rear.
8 2. For a vehicle for which two license plates are issued, the vehicle
9 owner shall display either of the following:
10 (a) One plate on the rear.
11 (b) One plate on the front and one plate on the rear.
12 3. FOR A TRUCK TRACTOR, ON THE FRONT.
13 B. A person shall display all license plates as required by subsection
14 A until their lawful use expires or is canceled or revoked. A person shall
15 maintain each license plate so it is clearly legible. A person shall
16 securely fasten each license plate to the vehicle as follows:
17 1. To prevent the plate from swinging.
18 2. At a height of at least twelve inches from the ground to the bottom
19 of the plate.
20 3. In a position to be clearly visible.

24 A. A person shall display the license plate or plates as follows:
25 1. EXCEPT AS PROVIDED IN PARAGRAPH 3 OF THIS SUBSECTION, for a motor
26 vehicle, motorcycle, trailer or semitrailer, on the rear.
27 2. For a vehicle for which two license plates are issued, the vehicle
28 owner shall display either of the following:
29 (a) One plate on the rear.
30 (b) One plate on the front and one plate on the rear.
31 3. FOR A TRUCK TRACTOR, ON THE FRONT.
32 B. A person shall display all license plates as required by subsection
33 A until their lawful use expires or is canceled or revoked. A person shall
34 maintain each license plate so it is clearly legible and so that the name of
35 this state at the top of the license plate is not obscured. A person shall
36 securely fasten each license plate to the vehicle as follows:
37 1. To prevent the plate from swinging.
38 2. At a height of at least twelve inches from the ground to the bottom
39 of the plate.
