Dear Chairman Miller:

We are widows, parents, adult children and other family members of coal miners who have been killed while working in Kentucky's underground mines, as well as working coal miners and our family members. We want to thank you for the excellent work you have done in Washington to make sure that we learn from the senseless coal mine tragedies that have occurred in Kentucky and to better protect our miners.

For the past 1½ years, we have worked diligently to get the legislators in Washington and Frankfort to improve federal and state mine safety laws so that other mining families will not have to suffer the anguish that we have endured - and the pain that we continue to suffer.

Unfortunately, America's coal mining families and communities continue to experience tragedies that could easily have been prevented. That is why we support your efforts, through H.R. 2768, the S-Miner Act, to strengthen the federal mine safety law.

Miners and their families shouldn't have to worry about threats to their jobs - or their personal safety - if they speak up when they encounter safety or health problems underground.

Miners should also have every available tool to make sure that if an accident does happen, they have the ability to escape harm.

Coal companies should be required to build stronger mine seals with substantial materials that will withstand a mine explosion and protect the miners who are working in the active areas underground.

And mine operators should be held accountable when they don't live up to their legal obligation to protect their employees who work every day under difficult circumstances.

Our coal miners deserve the very best protections that Congress can provide. There simply is no reason that miners should die underground while trying to provide for their families.

We therefore urge Congress to pass H.R. 2768 as soon as possible. The miners of Kentucky and the rest of our nation deserve the strongest possible protections, and we believe the S-Miner Act will provide those protections.

Thank you again for your work in championing the safety of America's miners in the U.S. House of Representatives.
