AN ACT

AMENDING TITLE 15, CHAPTER 7, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 15-702.01; RELATING TO SCHOOL CURRICULUM.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 15, chapter 7, article 1, Arizona Revised Statutes,
3 is amended by adding section 15-702.01, to read:

4 15-702.01. Home school completion affidavit; legal status

5 A. ANY STUDENT WHO HAS SATISFACTORILY COMPLETED THE EQUIVALENT OF
6 GRADE TWELVE IN A HOME SCHOOL PROGRAM MAY BE AWARDED A HOME SCHOOL COMPLETION
7 AFFIDAVIT BY THE PARENT, GUARDIAN OR OTHER PERSON WHO PROVIDED HOME SCHOOL
8 INSTRUCTION TO THAT PUPIL. THE HOME SCHOOL COMPLETION AFFIDAVIT SHALL
9 EITHER:

10 1. BE NOTARIZED AND IN THE FOLLOWING FORMAT:

34 B. FOR ALL PURPOSES RELATING TO POSTSECONDARY EDUCATION, VOCATIONAL
35 CERTIFICATION AND EMPLOYMENT, A HOME SCHOOL COMPLETION AFFIDAVIT HAS THE SAME
36 LEGAL STATUS, AND SHALL BE TREATED IN THE SAME MANNER, AS A HIGH SCHOOL
37 DIPLOMA.
