# A BILL

- To authorize the Secretary of the Interior to conduct a special resource study of sites associated with the life of César Estrada Chávez and the farm labor movement.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

## **3 SECTION 1. CÉSAR ESTRADA CHÁVEZ STUDY ACT.**

4 (a) SHORT TITLE.— This Act may be cited as the

5 "César Estrada Chávez Lands Legacy Study Act".

6 (b) FINDINGS.— Congress finds the following:

- 7 (1) On March 31, 1927, César Estrada Chávez
- 8 was born on a small farm near Yuma, Arizona.

1	(2) At age 10, Chávez and his family became
2	migrant farm workers after they lost their farm in
3	the Great Depression.
4	(3) Throughout his youth and into adulthood,
5	Chávez migrated across the Southwest, laboring in
6	fields and vineyards.
7	(4) During this period, Chávez was exposed to
8	the hardships and injustices of farm worker life.
9	(5) In 1952, Chávez's life as an organizer and
10	public servant began when he left the fields and
11	joined the Community Service Organization, a com-
12	munity-based self-help organization.
13	(6) While with the Community Service Organi-
14	zation, Chávez conducted—
15	(A) voter registration drives; and
16	(B) campaigns against racial and economic
17	discrimination.
18	(7) During the late 1950s and early 1960s,
19	Chávez served as the national director of the Com-
20	munity Service Organization.
21	(8) In 1962, Chávez founded the National
22	Farm Workers Association, an organization that—
23	(A) was the first successful farm workers
24	union in the United States; and

1	(B) became known as the "United Farm
2	Workers of America".
3	(9) From 1962 to 1993, as leader of United
4	Farm Workers of America, Chávez achieved for tens
5	of thousands of farm workers—
6	(A) dignity and respect;
7	(B) fair wages;
8	(C) medical coverage;
9	(D) pension benefits;
10	(E) humane living conditions; and
11	(F) other rights and protections.
12	(10) The leadership and humanitarianism of
13	César Chávez continue to influence and inspire mil-
14	lions of citizens of the United States to seek social
15	justice and civil rights for the poor and
16	disenfranchised.
17	(11) The life of César Chávez and his family
18	provides an outstanding opportunity to illustrate and
19	interpret the history of agricultural labor in the
20	western United States.
21	(c) RESOURCE STUDY.—Not later than 3 years after
22	the date of enactment of this Act, the Secretary of the
23	Interior (referred to in this section as the "Secretary")
24	shall complete a resource study of sites in the State of
25	Arizona, the State of California, and other States that are

4	(1) appropriate methods for preserving and in-
5	terpreting the sites; and
6	(2) whether any of the sites meets the criteria
7	for listing on the National Register of Historic
8	Places or designation as a national historic land-
9	mark under—
10	(A) the Act of August 21, 1935 (16 U.S.C.
11	461 et seq.); and
12	(B) the National Historic Preservation Act
13	(16 U.S.C. 470 et seq.).
14	(d) REQUIREMENTS.—In conducting the study under
15	this section, the Secretary shall—
16	(1) consider the criteria for the study of areas
17	for potential inclusion in the National Park System
18	under section $8(b)(2)$ of Public Law 91–383 (16
19	U.S.C. $1a-5(b)(2)$ ; and
20	(2) consult with—
21	(A) the César E. Chávez Foundation;
22	(B) the United Farm Workers Union;
23	(C) State and local historical associations
24	and societies; and

1	(D) the State Historic Preservation Offi-
2	cers of the State of Arizona, the State of Cali-
3	fornia, and any other State in which a site de-
4	scribed in subsection (a) is located.
5	(e) REPORT.—On completion of the study under sub-
6	section (a), the Secretary shall submit to the Committee
7	on Resources of the House of Representatives and the
8	Committee on Energy and Natural Resources of the Sen-
9	ate a report on—
10	(1) the findings of the study; and
11	(2) any recommendations of the Secretary.
12	(f) Authorization of Appropriations.—There

13 are authorized to be appropriated such sums as are nec-14 essary to carry out this section.
