**MEMORANDUM ON PROPOSED TARIFF LEGISLATION  
of the 109<sup>th</sup> Congress<sup>1</sup>**

**Nature of bill:** Extension of temporary duty suspension through 12/31/2009.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

The subject chemicals (see below) are classified in HTS subheading 3824.90.91 and are eligible for a temporary duty suspension under HTS headings 9902.29.83 and 9902.38.10.

**Product information, including uses/applications and source(s) of imports:**

Mixtures of sodium salts of iminodisuccinic acid are used as a chelating agent. The mixtures are sold in two versions, one a spray-dried and granulated powder (Baypure CX 100 solid G), and the other (Baypure CX 100/34%), a liquid 40 percent solution of the active ingredient. The solid product consists of a mixture of sodium salts of iminodisuccinic acid, standardized to a minimum content of 78 percent tetrasodium iminodisuccinate.

The products are used as a chelating agent in the detergent, agriculture, oil, pharmaceutical, paper and textiles industries to reduce water hardness, stabilize oxidation agents in aqueous solution, and remove unwanted metal ions. The products are imported from Germany.

**Technical comments:**<sup>3</sup>

The Commission notes that the active ingredient in the two headings 9902.29.83 and 9902.38.10 is mixed sodium salts of iminodisuccinic acid (provided for in subheading 3824.90.91). The Commission suggests that language be included in the bill that will modify Chapter 99 of the HTS by striking heading 9902.38.10, and modifying the article description of heading 9902.29.83 to include the phrase “, whether or not in water”, inserted after the word “acid” in the article description. Heading 9902.29.83 can then be modified by striking the existing effective date and inserting the new effective date in lieu thereof, as in the original intent of the bill.

<sup>3</sup> The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

## A BILL

To extend the duty suspension on Iminodisuccinate.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. IMINODISUCCINATE.**

4       (a) IN GENERAL.—Headings 9902.29.83 and  
5 9902.38.10 of the Harmonized Tariff Schedule of the  
6 United States (relating to mixtures of sodium salts) are  
7 each amended by striking “12/31/2006” and inserting  
8 “12/31/2009”.

9       (b) EFFECTIVE DATE.—The amendments made by  
10 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
