Dear Renee:

I am writing to express our organization's opinion on the proposed legislation referenced above. If the tariff calculation is changed so that the rate is applied on the drained weight of the imported cherries that will effectively reduce the tariff charges by as much as 50%. In turn, the cost to import cherries will go down and could reduce the market price offered for cherries grown in the United States.

Oregon growers would be negatively affected by the change. Some varieties of cherries are grown specifically for the brine market. Sweet cherries that do not make grade to sell in the fresh market due to size or quality issues can also be sold for brine. This allows a grower to recoup some of the costs of growing and harvesting a crop instead of showing a loss.

As Chairman of the Oregon Sweet Cherry Commission and on behalf of Oregon Sweet Cherry producers, I request that the change in the tariff calculation be dropped from this legislation. Thank you.
