AN ACT

AMENDING TITLE 41, CHAPTER 7, ARTICLE 8.1, ARIZONA REVISED STATUTES, BY
ADDING SECTION 41-1240; RELATING TO LOBBYING.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 41, chapter 7, article 8.1, Arizona Revised Statutes,
3 is amended by adding section 41-1240, to read:

4 41-1240. No gift registry; rules

5 A. THE SECRETARY OF STATE SHALL ESTABLISH A NO GIFT REGISTRY FOR STATE
6 OFFICERS WHO ARE SUBJECT TO THIS ARTICLE. THE SECRETARY OF STATE SHALL
7 PUBLISH AND UPDATE THE NO GIFT REGISTRY WITH THE ANNUAL REPORT ISSUED
8 PURSUANT TO SECTION 41-1239.

9 B. EXCEPT AS PROVIDED IN THIS SUBSECTION, A LOBBYIST, DESIGNATED
10 PUBLIC LOBBYIST OR AUTHORIZED PUBLIC LOBBYIST SHALL NOT GIVE ANY THING OF
11 VALUE TO PERSONS WHO PLACE THEIR NAMES IN THE NO GIFT REGISTRY, WITHOUT
12 REGARD TO WHETHER THE THING OF VALUE IS EXCLUDED FROM THE DEFINITION OF GIFT
13 PRESCRIBED IN SECTION 41-1231. A LOBBYIST, DESIGNATED PUBLIC LOBBYIST OR
14 AUTHORIZED PUBLIC LOBBYIST MAY GIVE INFORMATIONAL DIRECTORIES TO PERSONS WHO
15 PLACE THEIR NAMES IN THE NO GIFT REGISTRY.

16 C. THE SECRETARY OF STATE MAY ADOPT RULES TO IMPLEMENT THIS SECTION
17 SUBJECT TO THE FOLLOWING:

18 1. THE NO GIFT REGISTRATION IS VALID FROM THE TIME THE PERSON
19 REGISTERS UNTIL JANUARY 1 OF THE FOLLOWING YEAR, UNLESS THE PERSON REQUESTS
20 THE REMOVAL OF THAT PERSON'S NAME IN WRITING.

21 2. THE NO GIFT REGISTRATION SHALL BE IN WRITING.
