AN ACT

AMENDING TITLE 36, CHAPTER 29, ARTICLE 1, ARIZONA REVISED STATUTES, BY ADDING SECTION 36-2923; RELATING TO THE ARIZONA HEALTH CARE COST CONTAINMENT SYSTEM.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 36, chapter 29, article 1, Arizona Revised Statutes,
3 is amended by adding section 36-2923, to read:
4 36-2923. Members; employer information; report; public access;
5 definitions
6 A. NOTWITHSTANDING ANY OTHER LAW, EACH APPLICANT FOR SERVICES PURSUANT
7 TO THIS CHAPTER AND EACH APPLICANT FOR REDETERMINATION OF ELIGIBILITY SHALL
8 IDENTIFY THAT PERSON'S EMPLOYER AND THE EMPLOYER OF THAT PERSON'S SPOUSE. IF
9 THE APPLICANT IS A CHILD, THE APPLICANT'S PARENT OR RESPONSIBLE PARTY SHALL
10 IDENTIFY THE PARENT'S OR RESPONSIBLE PARTY'S EMPLOYER.
11 B. ON OR BEFORE NOVEMBER 15 OF EACH YEAR, THE ADMINISTRATION SHALL
12 PREPARE A REPORT THAT LISTS EACH EMPLOYER IDENTIFIED PURSUANT TO SUBSECTION
13 A, THE TOTAL NUMBER OF EMPLOYEES EMPLOYED BY EACH EMPLOYER AND THE TOTAL
14 NUMBER OF THOSE EMPLOYEES AND THEIR SPOUSES AND DEPENDENTS WHO ARE ENROLLED
15 PURSUANT TO THIS ARTICLE AND ARTICLE 4 OF THIS CHAPTER. IN PREPARING EACH
16 REPORT, THE ADMINISTRATION SHALL USE THE MOST RECENT DATA AVAILABLE FROM THE
17 DEPARTMENT OF ECONOMIC SECURITY.
18 C. THE ADMINISTRATION SHALL SUBMIT THIS REPORT TO THE GOVERNOR, THE
19 PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND
20 SHALL PROVIDE A COPY OF THE REPORT TO THE SECRETARY OF STATE AND THE DIRECTOR
21 OF THE ARIZONA STATE LIBRARY, ARCHIVES AND PUBLIC RECORDS.
22 D. REPORTS SUBMITTED PURSUANT TO THIS SECTION ARE PUBLIC DOCUMENTS.
23 E. FOR THE PURPOSES OF THIS SECTION:
24 1. "EMPLOYEE" MEANS A PERSON WHO IS COMPENSATED BY AN EMPLOYER,
25 WHETHER ON A FULL-TIME, PART-TIME OR SEASONAL BASIS.
26 2. "EMPLOYER" MEANS A BUSINESS WITH AT LEAST TWO HUNDRED FIFTY
27 EMPLOYEES IN THIS STATE.
