Product information, including uses/applications and source(s) of imports:

ortho/para-Toluenesulfonic acid, methyl ester is a synthetic organic chemical isomeric mixture used as an additive in the production of several products known as "trimers," each of which is a slightly different type of aliphatic isocyanate used in urethane applications such as automotive paints, architectural coatings, and other resin systems for automotive and coating applications. The proponent imports this product from India and Germany. The only competitive products for this chemical are also produced in India.
