ORDER

By the Accounting Policy Division, Common Carrier Bureau:

1. This Order dismisses the Letter of Appeal filed by Pinckneyville District #50 (Pinckneyville), Pinckneyville, Illinois, seeking review of a funding commitment decision issued by the Universal Service Administrative Company's Schools and Libraries Division on July 20, 1999.¹ The Commission received Pinckneyville's Letter of Appeal on December 20, 1999.² Under section 54.720 of the Commission's rules, any such appeal must be filed within 30 days of the issuance of the decision as to which review is sought.³ Documents are considered to be filed with the Commission only upon receipt.⁴ Because the instant Letter of Appeal was not filed within the specified 30-day period, it will be dismissed without further consideration.⁵
