- 1. At the request of KB Prime Media LLC ("KB Prime"), an applicant for a new station to operate on channel 62 at Hammond, Louisiana, the Commission has before it the Notice of Proposed Rule Making, 67 FR 40632, June 13, 2002, proposing the substitution of DTV channel 42 for NTSC channel 62. KB filed comments restating its interest in applying for DTV channel 42, if allotted.
- 2. We believe the public interest would be served by the substitution of DTV channel 42 for channel 62 since it would provide the community of Hammond with its first local DTV service. DTV channel 42 can be allotted to Hammond, Louisiana, as proposed, in compliance with the principle community coverage requirement of Section 73.625(a) at coordinates 29-58-57 N. and 89-57-09. DTV channel can be allotted with the following specifications:
