China is the fastest-growing major export market for U.S.-made goods and services. Exports of U.S.-made goods and services to China rose 22% in 2004 to \$34.7bn. Exports of Illinois-made goods and services to China rose 16% to \$923mn for the same period.

Top U.S. export prospects to China include information technologies, telecommunications equipment, software, energy, medical equipment, pharmaceuticals, pollution control, airport and ground support equipment, consumer products, building materials, automotive parts, agricultural chemicals, plastic materials and resins, grains and cotton.

While China has opened its market somewhat more widely to U.S. business after joining the World Trade Organization (WTO) in December 2001, it has still a long way to go to fully comply with its WTO obligations. Nowhere is this non-compliance more apparent than in the area of intellectual property rights protection.

China might, in fact, not be the right market for every U.S. company at this time. But if you do decide to do business in China, the U.S. & Foreign Commercial Service (USFCS) is ready to help you explore opportunities there.

Few people can articulate the realities of doing business in China better than Special Counsel to the U.S. Secretary of Commerce in China Bruce Blakeman. He has been based at the U.S. Embassy in Beijing since October 2003. His areas of responsibility include monitoring China's WTO accession, assessing Chinese market access policy development and developing strategies for U.S. company export promotion to China.

Before his deployment to Beijing, Mr. Blakeman served the Bush Administration as the Commerce Department's Deputy Assistant Secretary for Domestic Operations. He also spent many years in the private sector with market research firm Wirthin Worldwide, including three years in Singapore as Managing Director for Wirthin's Asia-Pacific operations.
