By the Chief, Video Division, Media Bureau:

- 1. The Commission has before it a Notice of Proposed Rulemaking¹ issued in response to a petition for rulemaking filed by Central Wyoming College ("CWC"), the licensee of single-channel station KPTW(TV), channel *6, Casper, Wyoming, requesting the substitution of channel *8 for post-transition digital channel *6 at Casper. CWC filed comments. No other comments were filed.
- 2. We believe the public interest would be served by substituting DTV channel *8 for DTV channel *6. KPTW(TV) has encountered interference problems on channel *6 from noncommercial educational FM stations in the Casper area, especially KDSP-FM, Casper. The public interest will be served by substitution of channel *8 as it will eliminate the interference problems and will result in no loss of service.
- 3. DTV channel *8 can be substituted for DTV channel *6 at Casper, Wyoming, as proposed, in compliance with the principal community coverage requirements of Section 73.625(a) of the Commission's rules, at coordinates 42-44-26 N. and 106-21-34 W. In addition, we find that this channel change meets the technical requirements set forth in Sections 73.616 and 73.623 of the Commission's rules with the following specifications:
