# S. 2340 – Emergency Supplemental Appropriations Act for the Department of Defense for Fiscal Year 2008

Calendar No. 484

S. 2340 was placed on the Senate Legislative Calendar on November 14, under the provisions of Rule XIV.

### **Noteworthy**

- Per a unanimous consent agreement, the Senate will vote on cloture on the motion to proceed to S. 2340 at 9:30 a.m. Friday, November 16. If cloture fails, the Senate will then vote on cloture on the motion to proceed to H.R. 4156, the Democrat Supplemental Appropriations Act for FY08.
- On Thursday, November 15, Minority Leader McConnell filed cloture on the motion to proceed to S. 2340.
- S. 2340 provides \$70.0 billion in emergency appropriations. The Administration requested \$191.0 billion in supplemental appropriations for the entire fiscal year 2008 for the Global War on Terror.
- S. 2340 does not include any of the objectionable provisions that were included in H.R. 4156, the Democrat Supplemental Appropriations Act for FY08. The White House threatened to veto H.R. 4156.

# **Background**

Per the request of Congress, the President submitted an FY08 emergency supplemental appropriations request for the Global War on Terror with the FY08 budget request in February. At the time, the Administration requested \$145.14 billion in emergency funds for FY08 with the expectation that the Administration would amend its request later in the year. On October 19, the Administration amended its initial request by increasing the request amount by \$45.9 billion, for a total of \$191.04 billion for FY08 supplemental appropriations for the Global War on Terror.

On November 14, the House passed H.R. 4156, a Supplemental Appropriations Bill for FY08, with funding restrictions and a goal to withdraw troops from Iraq by December 15, 2008. The Administration issued a veto threat against the bill.

# **Bill Provisions**

### Title I – Military Personnel

Military Personnel: Provides \$8.65 billion for the Department's Military Personnel.

# **Title II – Operation and Maintenance**

<u>Operation and Maintenance</u>: Provides \$49.20 billion for Operation and Maintenance accounts in support of Operation Iraqi Freedom and Operation Enduring Freedom. This spending provides funds for the incremental cost of ground operations, flying hours, logistics support, fuel, travel, and transportation. The majority of the "surge" costs are operation and maintenance costs.

## Title III – Procurement

**Procurement:** Provides \$5.14 billion for procurement in various procurement accounts. This spending provides funds for force protection equipment, the restoration of equipment lost in operations, the recapitalization of equipment used in operations, and the equipping of units supporting upcoming rotations.

### **Title IV – Revolving and Management Funds**

**Defense Working Capital Funds:** Provides \$1.00 billion.

#### **Title V – Other Department of Defense Programs**

<u>Other Department of Defense Programs</u>: Provides \$704.5 million for a range of Department programs. This funding includes: \$575.7 million for operation and maintenance; and \$128.8 million for Drug Interdiction and Counter-Drug Activities.

#### Title V – General Provisions

#### **General Provisions**

- Section 603 provides the Secretary of Defense with transfer authority up to \$3.0 billion.
- Section 606 provides up to \$500.0 million for the Commander's Emergency Response Program (CERP) in Iraq and Afghanistan.
- Section 609 requires the Secretary of Defense to provide a report, every 90 days, to Congress
  with a comprehensive set of performance indicators and measures for progress toward military
  and political stability in Iraq.

## **Possible Amendments**

No amendments were known at press time.
