A BILL

To amend the procedures that apply to consideration of

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE; REFERENCE; TABLE OF CON-
- 4 TENTS.
- 5 (a) Short Title.—This Act may be cited as the
- 6 "Class Action Fairness Act of 2002".
- 7 (b) Reference.—Whenever in this Act reference is
- 8 made to an amendment to, or repeal of, a section or other
- 9 provision, the reference shall be considered to be made to
- 10 a section or other provision of title 28, United States Code.
- 11 (c) Table of Contents.—The table of contents for

1 SEC. 2. FINDINGS AND PURPOSES.

2	(a) FINDINGS.—The Congress finds as follows:
3	(1) Class action lawsuits are an important and
4	valuable part of our legal system when they permit
5	the fair and efficient resolution of legitimate claims
6	of numerous parties by allowing the claims to be ag-
7	gregated into a single action against a defendant that
8	has allegedly caused harm.
9	(2) Over the past decade, there have been abuses
10	of the class action device that have harmed class
11	members with legitimate claims and defendants that
12	have acted responsibly, and that have thereby under-
13	mined public respect for our judicial system.
14	(3) Class members have been harmed by a num-
15	ber of actions taken by plaintiffs' lawyers, which pro-
16	vide little or no benefit to class members as a whole,
17	including—
18	(A) plaintiffs' lawyers receiving large fees,
19	while class members are left with coupons or
20	other awards of little or no value;
21	(B) unjustified rewards being made to cer-
22	tain plaintiffs at the expense of other class mem-
23	bers; and
24	(C) the publication of confusing notices that
25	prevent class members from being able to fully

understand and effectively exercise their rights.

1	(4) Through the use of artful pleading, plaintiffs
2	are able to avoid litigating class actions in Federal
3	court, forcing businesses and other organizations to
4	defend interstate class action lawsuits in county and
5	State courts where—
6	(A) the lawyers, rather than the claimants,
7	are likely to receive the maximum benefit;
8	(B) less scrutiny may be given to the merits
9	of the case; and
10	(C) defendants are effectively forced into set-
11	tlements, in order to avoid the possibility of huge
12	judgments that could destabilize their companies.
13	(5) These abuses undermine our Federal system
14	and the intent of the framers of the Constitution in
15	creating diversity jurisdiction, in that county and
16	State courts are—
17	(A) handling interstate class actions that
18	affect parties from many States;
19	(B) sometimes acting in ways that dem-
20	onstrate bias against out-of-State defendants;
21	and
22	(C) making judgments that impose their
23	view of the law on other States and bind the
24	rights of the residents of those States.



1	(6) Abusive interstate class actions have harmed
2	society as a whole by forcing innocent parties to settle
3	cases rather than risk a huge judgment by a local
4	jury, thereby costing consumers billions of dollars in
5	increased costs to pay for forced settlements and exces-
6	$sive\ judgments.$
7	(b) Purposes.—The purposes of this Act are—
8	(1) to assure fair and prompt recoveries for class
9	members with legitimate claims;
10	(2) to protect responsible companies and other
11	institutions against interstate class actions in State
12	courts;
13	(3) to restore the intent of the framers of the
14	Constitution by providing for Federal court consider-
15	ation of interstate class actions; and
16	(4) to benefit society by encouraging innovation
17	and lowering consumer prices.
18	SEC. 3. CONSUMER CLASS ACTION BILL OF RIGHTS AND IM-
19	PROVED PROCEDURES FOR INTERSTATE
20	CLASS ACTIONS.
21	(a) In General.—Part V is amended by inserting
22	after chapter 113 the following:
23	"CHAPTER 114—CLASS ACTIONS

1 "§ 1711. Judicial scrutiny of coupon and other

2 noncash settlements

- 3 "The court may approve a proposed settlement under
- 4 which the class members would receive noncash benefits or
- 5 would otherwise be required to expend funds in order to
- 6 obtain part or all of the proposed benefits only after a hear-
- 7 ing to determine whether, and making a written finding
- 8 that, the settlement is fair, reasonable, and adequate for
- 9 class members.

10 "§ 1712. Protection against loss by class members

- 11 "The court may approve a proposed settlement under
- 12 which any class member is obligated to pay sums to class
- 13 counsel that would result in a net loss to the class member
- 14 only if the court makes a written finding that nonmonetary
- 15 benefits to the class member outweigh the monetary loss.

16 "§ 1713. Protection against discrimination based on

17 geographic location

- 18 "The court may not approve a proposed settlement
- 19 that provides for the payment of greater sums to some class
- 20 members than to others solely on the basis that the class
- 21 members to whom the greater sums are to be paid are lo-
- 22 cated in closer geographic proximity to the court.

1 "§ 1714. Prohibition on the payment of bounties

- 2 "(a) In General.—The court may not approve a pro-
- 3 posed settlement that provides for the payment of a greater
- 4 share of the award to a class representative serving on be-
- 5 half of a class, on the basis of the formula for distribution
- 6 to all other class members, than that awarded to the other
- 7 class members.
- 8 "(b) Rule of Construction.—The limitation in
- 9 subsection (a) shall not be construed to prohibit any pay-
- 10 ment approved by the court for reasonable time or costs that
- 11 a person was required to expend in fulfilling his or her obli-
- 12 gations as a class representative.

13 "§ 1715. Clearer and simpler settlement information

- 14 "(a) Plain English Requirements.—Any court
- 15 with jurisdiction over a plaintiff class action shall require
- 16 that any written notice concerning a proposed settlement
- 17 of the class action provided to the class through the mail
- 18 or publication in printed media contain—
- 19 "(1) at the beginning of such notice, a statement
- in 18-point Times New Roman type or other func-
- 21 tionally similar type, stating 'LEGAL NOTICE:
- 22 YOU ARE A PLAINTIFF IN A CLASS ACTION
- 23 LAWSUIT AND YOUR LEGAL RIGHTS ARE AF-
- 24 FECTED BY THE SETTLEMENT DESCRIBED
- 25 IN THIS NOTICE.';



1	"(2) a short summary written in plain, easily
2	understood language, describing—
3	"(A) the subject matter of the class action;
4	"(B) the members of the class;
5	"(C) the legal consequences of being a mem-
6	ber of the class;
7	"(D) if the notice is informing class mem-
8	bers of a proposed settlement agreement—
9	"(i) the benefits that will accrue to the
10	class due to the settlement;
11	"(ii) the rights that class members will
12	lose or waive through the settlement;
13	"(iii) obligations that will be imposed
14	on the defendants by the settlement;
15	"(iv) the dollar amount of any attor-
16	ney's fee class counsel will be seeking, or if
17	not possible, a good faith estimate of the
18	dollar amount of any attorney's fee class
19	counsel will be seeking; and
20	"(v) an explanation of how any attor-
21	ney's fee will be calculated and funded; and
22	"(E) any other material matter.
23	"(b) Tabular Format.—Any court with jurisdiction
24	over a plaintiff class action shall require that the informa-
25	tion described in subsection (a)—



1	"(1) be placed in a conspicuous and prominent
2	location on the notice;
3	"(2) contain clear and concise headings for each
4	item of information; and
5	"(3) provide a clear and concise form for stating
6	each item of information required to be disclosed
7	under each heading.
8	"(c) Television or Radio Notice.—Any notice pro-
9	vided through television or radio (including transmissions
10	by cable or satellite) to inform the class members in a class
11	action of the right of each member to be excluded from the
12	class action or a proposed settlement of the class action,
13	if such right exists, shall, in plain, easily understood
14	language—
15	"(1) describe the persons who may potentially
16	become class members in the class action; and
17	"(2) explain that the failure of a class member
18	to exercise his or her right to be excluded from a class
19	action will result in the person's inclusion in the class
20	action or settlement.
21	"§ 1716. Definitions
22	"In this chapter—
23	"(1) Class action.—The term 'class action'
24	means any civil action filed in a district court of the

United States pursuant to rule 23 of the Federal

1	Rules of Civil Procedure or any civil action that is
2	removed to a district court of the United States that
3	was originally filed pursuant to a State statute or
4	rule of judicial procedure authorizing an action to be
5	brought by one or more representatives on behalf of a
6	class.
7	"(2) Class counsel.—The term 'class counsel'
8	means the persons who serve as the attorneys for the
9	class members in a proposed or certified class action.
10	"(3) Class members.—The term 'class mem-
11	bers' means the persons who fall within the definition
12	of the proposed or certified class in a class action.
13	"(4) Plaintiff class action.—The term
14	'plaintiff class action' means a class action in which
15	class members are plaintiffs.
16	"(5) Proposed settlement.—The term 'pro-
17	posed settlement' means an agreement that resolves
18	claims in a class action, that is subject to court ap-
19	proval and that, if approved, would be binding on the
20	class members.".
21	(b) Technical and Conforming Amendment.—The
22	table of chapters for part V is amended by inserting after
23	the item relating to chapter 113 the following:

1	SEC. 4. FEDERAL DISTRICT COURT JURISDICTION OF
2	INTERSTATE CLASS ACTIONS.
3	(a) Application of Federal Diversity Jurisdic-
4	TION.—Section 1332 is amended—
5	(1) by redesignating subsection (d) as subsection
6	(e); and
7	(2) by inserting after subsection (c) the fol-
8	lowing:
9	" $(d)(1)$ In this subsection—
10	"(A) the term 'class' means all of the class mem-
11	bers in a class action;
12	"(B) the term 'class action' means any civil ac-
13	tion filed pursuant to rule 23 of the Federal Rules of
14	Civil Procedure or similar State statute or rule of ju-
15	dicial procedure authorizing an action to be brought
16	by one or more representative persons on behalf of a
17	class;
18	"(C) the term 'class certification order' means an
19	order issued by a court approving the treatment of a
20	civil action as a class action; and
21	"(D) the term 'class members' means the persons
22	who fall within the definition of the proposed or cer-
23	tified class in a class action.
24	"(2) The district courts shall have original jurisdiction
25	of any civil action in which the matter in controversy ex-



1	ceeds the sum or value of \$2,000,000, exclusive of interest
2	and costs, and is a class action in which—
3	"(A) any member of a class of plaintiffs is a cit-
4	izen of a State different from any defendant;
5	"(B) any member of a class of plaintiffs is a for-
6	eign state or a citizen or subject of a foreign state and
7	any defendant is a citizen of a State; or
8	"(C) any member of a class of plaintiffs is a cit-
9	izen of a State and any defendant is a foreign state
10	or a citizen or subject of a foreign state.
11	"(3) Paragraph (2) shall not apply to any civil action
12	in which—
13	"(A)(i) the substantial majority of the members
14	of the proposed plaintiff class and the primary de-
15	fendants are citizens of the State in which the action
16	was originally filed; and
17	"(ii) the claims asserted therein will be governed
18	primarily by the laws of the State in which the action
19	was originally filed;
20	"(B) the primary defendants are States, State
21	officials, or other governmental entities against whom
22	the district court may be foreclosed from ordering re-
23	lief; or
24	"(C) the number of proposed plaintiff class mem-
25	bers is less than 100.



- 1 "(4) In any class action, the claims of the individual
- 2 class members shall be aggregated to determine whether the
- 3 matter in controversy exceeds the sum or value of
- 4 \$2,000,000, exclusive of interest and costs.
- 5 "(5) This subsection shall apply to any class action
- 6 before or after the entry of a class certification order by
- 7 the court with respect to that action.
- 8 "(6)(A) A district court shall dismiss any civil action
- 9 that is subject to the jurisdiction of the court solely under
- 10 this subsection if the court determines the action may not
- 11 proceed as a class action based on a failure to satisfy the
- 12 requirements of rule 23 of the Federal Rules of Civil Proce-
- 13 dure.
- 14 "(B) Nothing in subparagraph (A) shall prohibit
- 15 plaintiffs from filing an amended class action in Federal
- 16 court or filing an action in State court, except that any
- 17 such action filed in State court may be removed to the ap-
- 18 propriate district court if it is an action of which the dis-
- 19 trict courts of the United States have original jurisdiction.
- 20 "(C) In any action that is dismissed under this para-
- 21 graph and is filed by any of the original named plaintiffs
- 22 therein in the same State court venue in which the dis-
- 23 missed action was originally filed, the limitations periods
- 24 on all reasserted claims shall be deemed tolled for the period
- 25 during which the dismissed class action was pending. The



1	limitations periods on any claims that were asserted in a
2	class action dismissed under this paragraph that are subse-
3	quently asserted in an individual action shall be deemed
4	tolled for the period during which the dismissed action was
5	pending.
6	"(7) Paragraph (2) shall not apply to any class action
7	brought by shareholders that solely involves a claim that
8	relates to—
9	"(A) a claim concerning a covered security as
10	defined under section 16(f)(3) of the Securities Act of
11	1933 and section $28(f)(5)(E)$ of the Securities Ex-
12	change Act of 1934;
13	"(B) the internal affairs or governance of a cor-
14	poration or other form of business enterprise and
15	arises under or by virtue of the laws of the State in
16	which such corporation or business enterprise is in-
17	corporated or organized; or
18	"(C) the rights, duties (including fiduciary du-
19	ties), and obligations relating to or created by or pur-
20	suant to any security (as defined under section
21	2(a)(1) of the Securities Act of 1933 and the regula-
22	tions issued thereunder).
23	"(8) For purposes of this subsection and section 1453

24 of this title, an unincorporated association shall be deemed



1	to be a citizen of the State where it has its principal place
2	of business and the State under whose laws it is organized.
3	"(9) For purposes of this section and section 1453 of
4	this title, a civil action that is not otherwise a class action
5	as defined in paragraph (1)(B) of this subsection shall nev-
6	ertheless be deemed a class action if—
7	"(A) the named plaintiff purports to act for the
8	interests of its members (who are not named parties
9	to the action) or for the interests of the general public,
10	seeks a remedy of damages, restitution, disgorgement,
11	or any other form of monetary relief, and is not a
12	State attorney general; or
13	"(B) monetary relief claims in the action are
14	proposed to be tried jointly in any respect with the
15	claims of 100 or more other persons on the ground
16	that the claims involve common questions of law or
17	fact.
18	In any such case, the persons who allegedly were injured
19	shall be treated as members of a proposed plaintiff class
20	and the monetary relief that is sought shall be treated as
21	the claims of individual class members. The provisions of
22	paragraphs (3) and (6) of this subsection and subsections
23	(b)(2) and (d) of section 1453 shall not apply to civil ac-
24	tions described under subparagraph (A). The provisions of

25 paragraph (6) of this subsection, and subsections (b)(2) and



1	(d) of section 1453 shall not apply to civil actions described
2	under subparagraph (B).".
3	(b) Conforming Amendments.—
4	(1) Section 1335(a)(1) is amended by inserting
5	"(a) or (d)" after "1332".

8	SEC. 5. REMOVAL OF INTERSTATE CLASS ACTIONS TO FED-
9	ERAL DISTRICT COURT.
10	(a) In General.—Chapter 89 is amended by adding
11	after section 1452 the following:
12	"§ 1453. Removal of class actions
13	"(a) Definitions.—In this section, the terms 'class',
14	'class action', 'class certification order', and 'class member'
15	have the meanings given these terms in section $1332(d)(1)$.
16	"(b) In General.—A class action may be removed to
17	a district court of the United States in accordance with this
18	chapter, without regard to whether any defendant is a cit-
19	izen of the State in which the action is brought, except that
20	such action may be removed—
21	"(1) by any defendant without the consent of all
22	defendants; or
23	"(2) by any plaintiff class member who is not a
24	named or representative class member without the
25	consent of all members of such class.



- 1 "(c) When Removable.—This section shall apply to
- 2 any class action before or after the entry of a class certifi-
- 3 cation order in the action, except that a plaintiff class mem-
- 4 ber who is not a named or representative class member of
- 5 the action may not seek removal of the action before an
- 6 order certifying a class of which the plaintiff is a class
- 7 member has been entered.
- 8 "(d) Procedure for Removal.—The provisions of
- 9 section 1446 relating to a defendant removing a case shall
- 10 apply to a plaintiff removing a case under this section, ex-
- 11 cept that in the application of subsection (b) of such section
- 12 the requirement relating to the 30-day filing period shall
- 13 be met if a plaintiff class member files notice of removal
- 14 within 30 days after receipt by such class member, through
- 15 service or otherwise, of the initial written notice of the class
- 16 action.
- 17 "(e) Review of Orders Remanding Class Actions
- 18 TO STATE COURTS.—The provisions of section 1447 shall
- 19 apply to any removal of a case under this section, except
- 20 that, notwithstanding the provisions of section 1447(d), an
- 21 order remanding a class action to the State court from
- 22 which it was removed shall be reviewable by appeal or oth-
- 23 erwise.
- 24 "(f) Exception.—This section shall not apply to any
- 25 class action brought by shareholders that solely involves—



1	"(1) a claim concerning a covered security as de-
2	fined under section 16(f)(3) of the Securities Act of
3	1933 and section $28(f)(5)(E)$ of the Securities Ex-
4	change Act of 1934;
5	"(2) a claim that relates to the internal affairs
6	or governance of a corporation or other form of busi-
7	ness enterprise and arises under or by virtue of the
8	laws of the State in which such corporation or busi-
9	ness enterprise is incorporated or organized; or
10	"(3) a claim that relates to the rights, duties (in-
11	cluding fiduciary duties), and obligations relating to
12	or created by or pursuant to any security (as defined
13	under section 2(a)(1) of the Securities Act of 1933
14	and the regulations issued thereunder).".
15	(b) Removal Limitation.—Section 1446(b) is
16	amended in the second sentence by inserting "(a)" after
17	"section 1332".
18	(c) Technical and Conforming Amendments.—The
19	table of sections for chapter 89 is amended by adding after
20	the item relating to section 1452 the following:
	"1453. Removal of class actions.".
21	SEC. 6. APPEALS OF CLASS ACTION CERTIFICATION OR-
22	DERS.
23	(a) In General.—Section 1292(a) is amended by in-
24	serting after paragraph (3) the following:

1	"(4) Orders of the district courts of the United
2	States granting or denying class certification under
3	rule 23 of the Federal Rules of Civil Procedure, if no-
4	tice of appeal is filed within 10 days after entry of
5	the order.".
6	(b) DISCOVERY STAY.—All discovery and other pro-
7	ceedings shall be stayed during the pendency of any appeal
8	taken pursuant to the amendment made by subsection (a),
9	unless the court finds upon the motion of any party that
10	specific discovery is necessary to preserve evidence or to pre-
11	vent undue prejudice to that party.
12	SEC. 7. EFFECTIVE DATE.
13	The amendments made by this Act shall apply to any

14 civil action commenced on or after the date of the enactment
