# \*\*DIRECTIONS\*\*

# I. Coming I-95 North (from N.Y.)

Take I-95 North to Exit 47 just before the I-95 merge with I-91 (left hand exit Downtown RR Station/Rte 34 Connector). Go to the far right lane and take exit 1 (Church Street). Take a right off exit. Proceed to Chapel Street and take a right. Go two lights to State Street and take a right. Proceed to the intersection of State Street & George Street. Right after this intersection (Knight of Columbus will be on your left) take a right into the Pro Park Parking Lot (Train Station Parking). See walking directions below.

## II. Coming I-95 South (from New London)

Take I-95 South to Exit 47(Downtown RR Station/Rte 34 Connector). Go to the far right lane and take exit 1 (Church Street). Take a right off exit. Proceed to Chapel Street and take a right. Go two lights to State Street and take a right. Proceed to the intersection of State Street & George Street. Right after this intersection (Knight of Columbus will be on your left) take a right into the Pro Park Parking Lot (Train Station Parking). See walking directions below.

# III. Coming I-91 South (from Hartford)

Take I-91 South to Exit 4- State Street exit. At the bottom of the ramp take a right. At the next light take a quick left onto State Street. Proceed to the intersection of State Street & George Street. Right after this intersection (Knight of Columbus will be on your left) take a right into the Pro Park Parking Lot (Train Station Parking) See walking directions below.

### IV. Coming from I-84 West (from Waterbury)

Take I-84 West to Rte 8 South. Take Exit 15 towards Derby/New Haven. At end of ramp take a right. At next light take right onto Rte 34 & follow 7.8 miles. Take a right onto Ella Grasso Blvd. At 2<sup>nd</sup> light take left onto Legion Ave -which becomes S. Frontage Rd. Take a left onto Church St. Proceed to Chapel Street and take a right. Go two lights to State Street and take a right. Proceed to the intersection of State Street & George Street. Right after this intersection (Knight of Columbus will be on your left) take a right into the Pro Park Parking Lot (Train Station Parking) See walking directions below.

Alternate Route: Take Rt 69 South through Prospect, Bethany & Woodbridge. (Whalley Ave) which turns into Elm St. Go straight on Elm Street & take a right onto State Street. Proceed to the intersection of State Street & George Street. Right after this intersection (Knight of Columbus will be on your left) take a right into the Pro Park Parking Lot (Train Station Parking). See walking directions below.

### \*PARKING\*

Do not park at meters on street. Have your summons ready and inform the parking attendant that you are here for jury service so you do not have to pay for parking. You will be given a receipt that you should bring to court with you. A jury clerk will then issue you a validation sticker. If this lot is full, there are lots on State, Chapel, Elm & Crown Streets. \* If you park anywhere besides the Pro Park lot that you are directed to in the above directions you will be responsible to pre-pay for parking (from \$12.00 to \$20.00 in cash) up front, and will be reimbursed by the court, with a receipt, at a later date. The court reimburses up to \$15.00 per day for parking. PLEASE NOTE: there are many Pro Park lots on State Street, but the ONLY one we validate for is right after the intersection of State Street & George Street.

### \*WALKING DIRECTIONS from Pro Park Lot\*

Take a left out of the Pro Park lot. You will be on State Street (Knight of Columbus will be on your right). Proceed to Chapel Street and take a left. Take a right onto Church Street. U.S. District Court will be on your right (141 Church Street).

#### WHAT CAN I BRING?

- Please bring photo identification and your jury summons with you.
- Do not bring lap top computers, you may bring your own reading materials.
- Be prepared to pay cash for parking fees /lunch if necessary.
- There are no vending machines in the building. Beverages are not allowed unless they are in a sealed container. Beverages in open containers (ie: Dunkin Donuts coffee) are prohibited. You may bring a snack with you to be consumed at an assigned break time.
- Cellular telephones are prohibited in Federal Courthouses effective 7/1/06. The US Marshal's service will maintain a system for collecting & returning cell phones at security check in.
- Because jury selection days vary in length, you may be required to appear for just a few hours or as late as 5:30 p.m., therefore please make all personal arrangements for your summons date in advance.
