HOUSE BILL 2100

AN ACT

AMENDING SECTIONS 28-2354 AND 28-2414, ARIZONA REVISED STATUTES; RELATING TO
LICENSE PLATES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 28-2354, Arizona Revised Statutes, is amended to
3 read:

4 28-2354. License plates; attachment

5 A. A person shall display the license plate or plates as follows:

6 1. For a motor vehicle, motorcycle, trailer or semitrailer, on the
7 rear.

8 2. For a vehicle for which two license plates are issued, the vehicle
9 owner shall display either of the following:

10 (a) One plate on the rear.

11 (b) One plate on the front and one plate on the rear.

12 B. A person shall display all license plates as required by subsection
13 A until their lawful use expires or is canceled or revoked. A person shall
14 maintain each license plate so it is clearly legible **AND SO THAT THE NAME OF**
15 **THIS STATE AT THE TOP OF THE LICENSE PLATE IS NOT OBSCURED.** A person shall
16 securely fasten each license plate to the vehicle as follows:

17 1. To prevent the plate from swinging.

18 2. At a height of at least twelve inches from the ground to the bottom
19 of the plate.

20 3. In a position to be clearly visible.

21 Sec. 2. Section 28-2414, Arizona Revised Statutes, is amended to read:

22 28-2414. Veteran special plates

23 A. The department shall issue veteran special plates to:

24 1. A person who submits satisfactory proof to the department that the
25 person is a veteran.

26 2. The immediate family member of a person who has been issued a
27 license plate pursuant to this section.

28 B. The department shall issue veteran special plates for motorcycles
29 if an outside source pays thirty-two thousand dollars to the department by
30 December 31, 2004 for the establishment of the veteran special plate for
31 motorcycles.

32 C. The veteran special plates shall contain:

33 1. A red, white and blue design.

34 2. An American flag in the center of the plate.

35 3. The designation "veteran" at the bottom of the plate.

36 D. Of the twenty-five dollar fee required by section 28-2402 for
37 original veteran special plates and for renewal of veteran special plates,
38 eight dollars is a special plate administration fee and seventeen dollars is
39 a veteran plate annual donation.

40 E. The department shall deposit, pursuant to sections 35-146 and
41 35-147, all special plate administration fees in the state highway fund
42 established by section 28-6991 and shall deposit the veteran plate annual
43 donations in the veterans' donations fund established by section 41-608.

1 F. A REQUEST FOR SPECIAL PLATES ISSUED UNDER THIS SECTION MAY BE
2 COMBINED WITH A REQUEST FOR A PERSONALIZED SPECIAL PLATE ISSUED PURSUANT TO
3 SECTION 28-2406. THE DEPARTMENT SHALL PRESCRIBE THE FORM FOR THE
4 REQUEST. THE INITIAL COMBINED REQUEST IS SUBJECT TO THE FEE REQUIRED FOR
5 VETERAN SPECIAL PLATES AND THE FEE REQUIRED FOR THE OTHER SPECIAL PLATE
6 ISSUED PURSUANT TO SECTION 28-2406. ON RENEWAL OF THE COMBINED SPECIAL
7 PLATES, THE FEE IS TWENTY-FIVE DOLLARS AND SHALL BE DIVIDED AND DEPOSITED AS
8 PRESCRIBED IN SUBSECTIONS D AND E OF THIS SECTION.

10 Section 28-2354, Arizona Revised Statutes, as amended by this act, is
11 effective from and after December 31, 2008.
