This synthetic organic chemical, known by its initials, TMTD, is used in rubber compounding to provide good heat aging and compression set resistance for rubber products produced by sulfurless and EV vulcanization systems. This chemical is imported from Germany.

#### **Technical comments:**<sup>3</sup>

The Commission notes that the word "disulfide" should not be capitalized.

The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
