## **ORDER**

By the Telecommunications Access Policy Division, Wireline Competition Bureau:

1. Allendale County Schools, Allendale, South Carolina (Allendale), seeks review of a June 9, 2003 decision by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator). On September 25, 2003, Allendale appealed the decision to SLD, but SLD denied the appeal because Allendale filed the appeal more than 60 days after the decision was rendered. We affirm SLD's decision. For a review of decisions by SLD, appeals to SLD must be filed within 60 days of the issuance of the SLD decision date. Here, Allendale filed its appeal to SLD after the 60-day period, in contravention of our rules. We therefore deny the Request for Review.
