REPORT AND ORDER (Proceeding Terminated)

By the Chief, Video Division:

- 1. At the request of Davis Television Topeka, LLC ("Davis"), an applicant for a construction permit for new station to operate on channel 43 at Topeka, Kansas, the Commission has before it the Notice of Proposed Rule Making, 17 FCC Rcd 12727 (2002), proposing the substitution of channel 22 for channel 43. Davis filed comments affirming its continuing interest in applying for channel 22, if allotted. Montgomery Communications, Inc. ("Montgomery"), filed comments.²
- 2. We believe the public interest would be served by substituting channel 22 for channel 43. A staff engineering analysis indicates that channel 22 can be allotted to Topeka with a plus offset consistent with the minimum distance separation requirements of Sections 73.610 and 73.698.³ With regard to Montgomery's concern, after the effective date of this channel substitution, the Commission will open a window to afford parties an opportunity to file competing applications.
- 3. Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective November 25, 2002, the TV Table of Allotments, Section 73.606(b) of the Commission's Rules, IS AMENDED, with respect to the community listed below, to read as follows:

¹ Davis filed its petition pursuant to the provisions outlined in the Commission's Public Notice ("Public Notice") released on February 6, 2002. In that *Pubic Notice*, the Commission announced a window filing opportunity to allow applicants with certain pending requests for new analog television stations on channels 52-59 to modify their requests. Davis on July 17, 2000, had filed a petition for rule making seeking the allotment of NTSC channel 55 in lieu of channel 43. However, since the Commission reallocated channels 52-59, Davis amended its petition to specify channel 22 in lieu of channel 55. See Reallocation and Service Rules for 698-746 MHz Spectrum Band (Television Channels 52-59), Report and Order in GN Docket No. 01-74, 17 FCC Rcd 1022 (2002).

² Montgomery states that it is a prospective applicant for the channel, whether it remains 43 or changes to 22 and wants assurance that a filing window will be opened for competing applications.

³ The coordinates for channel 22 at Topeka are North Latitude 39-00-00 and West Longitude 96-07-45.

- 4. IT IS FURTHER ORDERED, That within 45 days of the effective date of this <u>Order</u>, Davis Television Topeka, LLC shall submit to the Commission a minor change application for a construction permit (FCC Form 301) specifying TV Channel 22+ in lieu of TV Channel 43.
