## **REPORT AND ORDER** (Proceeding Terminated)

Adopted: November 2, 2001 Released: November 7, 2001

By the Chief, Video Services Division:

- 1. At the request of Montana State University ("MSU"), licensee of noncommercial station KUSM(TV), NTSC channel \*9, Bozeman, Montana, the Commission has before it the <u>Notice of Proposed Rule Making</u>, 16 FCC Rcd 14500 (2001), requesting the substitution of DTV channel \*8 for station KUSM(TV)'s assigned DTV channel \*20. MSU and KCTZ Communications, Inc. filed comments supporting the channel substitution proposal at Bozeman.<sup>1</sup> No other comments were received.
- 2. We believe the public interest would be served by substituting DTV channel \*8 for DTV channel \*20 since it will permit station KUSM(TV) to reduce its build-out and operating costs while reducing some of its terrain shielding problems. DTV channel \*8 can be allotted to Bozeman, Montana, as proposed, in compliance with the principle community coverage requirements of Section 73.625(a) at coordinates 45-40-24 N. and 110-52-02 W. Since the community of Bozeman is located within 400 kilometers of the U.S.-Canadian border, concurrence by the Canadian government has been obtained for this allotment. In addition, we find that this channel is acceptable under the 2 percent criterion for *de minimis* impact that is applied in evaluating requests for modification of initial DTV allotments under Section 73.623(c)(2) for Station KUSM(TV) with the following specifications:

Accordingly, pursuant to the authority contained in Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b) and 0.283 of the Commission's Rules, IT IS ORDERED, That effective December 24, 2001, the DTV Table of Allotments, Section 73.622(b) of the Commission's Rules, IS AMENDED, with respect to the community listed below, to read as follows:
