ORDER

By the Assistant Chief, Telecommunications Access Policy Division:

- 1. On February 25, 2003, U.S. Xchange of Indiana L.LC. D/B/A Choice One Communications and its Parent, Choice One Communications, Inc. (Choice One) filed a petition requesting the Commission to waive the North American Numbering Plan Administrator's (NANPA) decision to deny Choice One's request for 1,000 numbers so that Choice One may satisfy a specific customer request.¹
- 2. On May 13, 2003, Choice One filed a motion to withdraw its Petition.² According to Choice One, it filed the above-captioned Petition with the Commission because, although section 52.15(g)(3)(iv) of the Commission's rules allows carriers to challenge the NANPA's decision with the appropriate state commission,³ Choice One believed that the Indiana Utility Regulatory Commission (Indiana Commission) would not respond to its request. Choice One seeks to withdraw the Petition because the Indiana Commission has indicated that it will address Choice One's Petition.⁴ Given that Choice One intends to seek relief from the Indiana Commission, we grant Choice One's motion to withdraw its Petition.
