The chemical name in the proposed article description is not included in the eo nomine subheading 2933.39.20. That subheading reference should be 2933.39.91. The article description should therefore be modified to read as follows:

Decanedioic acid, bis(2,2,6,6-tetramethyl-4-piperidinyl) ester (CAS No. 52829-07-9) (provided for in subheading 2933.39.91)

The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
