## HAWAII FRUIT OUTPUT DOWN BUT VALUE UP FOR 2003

Hawaii fruit growers harvested 704.9 million pounds of fruit for fresh and processed utilization in 2003, down 2 percent from the previous year, according to the Hawaii Agricultural Statistics (HAS). Total fruit acreage fell 13 percent to 22,401 acres, mainly due to a decrease in pineapple acreage. Compared with 2002, harvests were smaller for all fruits except banana and avocado. The value for most fruits was higher than a year ago, together totaling $\$ 129.7$ million and 3 percent above 2002. Farm values increased for pineapple, papaya, banana, other fruits, and avocado. Honolulu County continued to rank first for fruit value, with pineapple accounting for the majority.

## 2003 FRUIT VALUE BY COUNTIES

- HAWAII

Farm sales from Hawaii County totaled $\$ 19.9$ million, up 12 percent from a year ago and the highest value since 1997. More sales of papayas, bananas, tropical specialty fruits, and avocados contributed toward the increase. Papaya sales made up 56 percent of the island's total with farm receipts of \$11.0 million. Banana output continued to be ranked second. Tropical specialty fruits were up 21 percent from last year. Guava and citrus were lower than 2002.

## - KAUAI

Kauai County fruit sales for 2003 decreased 29 percent from the previous year to $\$ 1.7$ million. Guavas, tropical specialty fruits, bananas, and papayas accounted for virtually all the value. Avocados and citrus made up the remainder.

## MAUI

The 2003 fruit value for Maui County at $\$ 31.3$ million increased 1 percent from 2002. Pineapple accounted for 95 percent of the Maui County value. Strawberries, bananas, papayas, tropical specialty fruits, and other fruits made up the rest of the value.

## - HONOLULU

Fruit grown in Honolulu County totaled $\$ 76.8$ million in 2003 compared to $\$ 74.7$ million during the previous year and increasing after three consecutive years of decline. The increase in value was mainly due to larger pineapple output. Revenues from other fruits accounted for 5 percent of the county's total. Honolulu County continues to lead the remaining counties in fruit value statewide.

## 2003 PROCESSED FRUITS

## GUAVAS

Hawaii processed guava utilization in 2003 totaled 6.7 million pounds, down for the third consecutive year and 31 percent lower than 2002. A labor dispute at a large operation during peak harvesting and low prices contributed towards the drop in utilization. Total acreage was down 30 acres to 610, and harvested acres dropped 20 to 530 in 2003. On Hawaii County during the last six years, acreage has been declining and influenced by limited markets and lower prices. Some growers have abandoned guava and began growing other crops. Reduced guava sales lowered value 36 percent from the previous year to $\$ 925$ thousand.

## - PAPAYAS

Processed papaya utilization decreased 44 percent in 2003 to 1.8 million pounds. Processed papayas accounted for 4 percent of papaya utilization compared to 7 percent last year.

## - PINEAPPLES

Processed pineapple utilization totaled 366 million pounds in 2003, down 10 percent from 2002. About 58 percent of the State's pineapple crop was processed during the year.

## - OTHER PROCESSED FRUITS

About 62 thousand pounds of the other fruits were utilized for processing in 2003, up 55 percent from the previous year. Wine grape and passion fruit are some of the other processed fruits.

## 2003 FRESH FRUITS

## - AVOCADOS

Hawaii's 2003 avocado crop totaled 760,000 pounds, up 9 percent from 2002. A 20-percent increase in harvested acreage to 300 acres is the main reason for the higher output. Farm prices averaged 62.0 cents per pound in 2003, up 11 percent from the 56.0 cents per pound average of 2002. Local growers benefitted from higher farm prices in California as that state experienced a cyclically smaller crop. California dominates U.S. production of avocados by accounting for approximately 90 percent of the nation's total output. The combined boost in output and farm prices in 2003, resulted in a record-high farm revenue of $\$ 471,000$ for Hawaii growers, up 20 percent from the previous year.

## - BANANAS

Hawaii banana output for 2003 totaled 22.5 million pounds, increasing 13 percent from 2002 and up after two years of decline. Banana Bunchy Top Virus (BBTV) remains a concern for growers on all major islands. Growers continued their ongoing monitoring and roguing programs to manage the disease. Weather for 2003 was favorable for orchards with no major wind damage but exceptional periods of heavy rains. Young plants made good progress. In 2003, total acreage increased 50 acres, to 1,560 and harvested acreage totaled 1,350 acres, up 20 from the previous year. Hawaii and Honolulu Counties accounted for the majority of the acreage. Farm price for 2003 averaged 41.0 cents per pound, down 2.0 cents from a year ago. More bananas pushed the value up from $\$ 8.6$ million in 2002 to $\$ 9.2$ million in 2003.

## - PAPAYAS

Fresh papaya utilization totaled 40.8 million pounds in 2003, 4 percent below last year and declining for the second consecutive year. Fewer harvested acres and drier conditions contributed toward the lower output. Fresh fruit accounted for virtually all utilization with 96 percent of the total. Outshipments made up 46 percent of the fresh utilization. The State's harvested 2003 papaya acreage was down 155 acres to 1,565 acres mainly due to smaller acreage on Hawaii County. Growers planted mainly Rainbow and Kapoho varieties.

## PINEAPPLES

Fruit harvested for fresh sales totaled 264 million pounds in 2003, up 13 percent from the 2002 total. Fresh sales accounted for 42 percent of the total pineapple production.

## - OTHER FRESH FRUITS

Other fresh fruits totaled 2.3 million pounds in 2003, down 8 percent from 2002. About 97 percent of these other fruits were utilized for fresh consumption. Some of the more important fruits in this category were atemoya, grapefruit, lime, longan, lychee, mango, orange, persimmon, rambutan, starfruit, strawberry, tangelo, and tangerine.
