1 Overview

A Background

The William A. Jump Memorial Foundation Award is presented in recognition of outstanding service in public administration. It was established in 1950 in honor of the late William A. Jump, Budget and Finance Officer of USDA, recognized throughout the Federal Government and nationally for his leadership and distinguished contributions to effective public administration. It is supported through private contributions.

The recognition provided by the William A. Jump Memorial Award is intended to serve as an encouragement to young people to promote interest, growth, development, and high level performance in public administration.

A golden key and a certificate will be presented to the winner at the 60th Secretary Annual Honor Awards Ceremony, which will take place on October 11, 2007, in Washington, DC.

B Purpose

This notice informs all Federal employees of the opportunity to submit nominations for the 2007 William A. Jump Memorial Award. All nominations must be submitted by **COB Tuesday, July 31, 2007**.

C Equal Opportunity/Workforce Diversity Policy

In keeping with the Secretary's initiative to promote equal opportunity in employment and programs, agencies are encouraged to consider nominations from all segments of the workforce. All nominees are eligible for the same level of recognition.

It is USDA's policy and practice to prohibit discrimination against any employee on the basis of race, color, religion, sex, age, disability, marital status, political affiliation, national origin, or sexual orientation.

2 Criteria

A Nominations Allocation

The Under Secretary's office has requested the following number of nominations be forwarded for consideration:

- FAS 1 primary nomination
- FSA 1 primary nomination
- RMA 1 primary nomination.

B Eligibility

The nominee must be a civilian career employee of the Federal Government who has not reached his or her 37th birthday, as of December 31, 2006. Work performance of the employee over a considerable period of time (no less than 5 years) in either a line or staff position, must demonstrate:

- outstanding competence and interest in any area of public administration
- leadership shown in the direction or development of programs
- creativity and resourcefulness
- close adherence to the basic principles of enlightened public service
- integrity
- dedication to duty.

For the purpose of the 2007 William A. Jump Memorial Award, the term "work" refers to both line or staff activity and the term "public administration" covers all aspects of executive-administration direction, supervision, and development of Federal activities.

The William A. Jump Memorial Foundation recommends that agencies consider employees from throughout the country, and that nominees for the 2007 William A. Jump Award be given recognition in agency publications for their achievements and services. USDA believes such action would help to stimulate active interest in fostering a more effective public service.

3 Nomination

A Completing Nomination

Each agency shall submit 6 copies of the nomination. Only 1 employee may be nominated by each agency. Exhibit materials, such as copies of publications may be attached, but all of the following basic information requested should be included in the nomination letter. Only 1 complete set of exhibits and publications need to be submitted. Information should be typewritten, single-spaced, with new subject paragraphs double-spaced numbered to correspond with the following.

The recommendation shall be signed by the nominee and the division head or designee. To be eligible for the 2007 William A. Jump Award, all nominations must be received no later than **COB Tuesday**, **July 31**, **2007**.
